3 Be it enacted by the People of the State of Illinois,
4 represented in the General Assembly:

5 Section 5. The Metropolitan Water Reclamation District
6 Act is amended by changing Section 4.32 as follows:

- 8 Sec. 4.32. <u>Veteran's preference</u>.

9 <u>(a) A person who served on active duty in the United</u> 10 <u>States Army, Navy, Air Force, Marine Corps, or Coast Guard</u> 11 <u>for a period of more than 180 consecutive days and was</u> 12 <u>honorably discharged from that service is entitled to a</u> 13 <u>veteran's preference under this Section.</u>

For the purpose of this Section, "active duty" does not include training or inactive duty performed as a member of the National Guard or a Reserve component of the armed forces.

18 (b) The Director of Personnel shall give preference for 19 an original or promotional appointment to a person qualifying for a veteran's preference under this Section whose name 20 appears on an original or promotional eligible register by 21 22 adding 5 points to the final grade that the person receives 23 as the result of any original or promotional examination held on or after the effective date of this amendatory Act of the 24 92nd General Assembly. 25

26 (c) The changes made to this Section by this amendatory
27 Act of the 92nd General Assembly are not intended to affect
28 any preference granted under this Section before the
29 effective date of this amendatory Act.
