- 2 Be it enacted by the People of the State of Illinois,
- 3 represented in the General Assembly:
- 4 Section 5. The State Finance Act is amended by adding
- 5 Section 5.570 as follows:
- 6 (30 ILCS 105/5.570 new)
- 7 <u>Sec. 5.570. The Stop Neuroblastoma Fund.</u>
- 8 Section 10. The Illinois Vehicle Code is amended by
- 9 adding Section 3-654 as follows:
- 10 (625 ILCS 5/3-654 new)
- 11 <u>Sec. 3-654. Stop Neuroblastoma license plates.</u>
- 12 (a) The Secretary, upon receipt of an application made
- in the form prescribed by the Secretary, may issue special
- 14 <u>registration plates designated as Stop Neuroblastoma license</u>
- 15 plates. The special plates issued under this Section shall be
- 16 <u>affixed</u> only to passenger vehicles of the first division and
- 17 <u>motor vehicles of the second division weighing not more than</u>
- 18 <u>8,000 pounds</u>. Plates issued under this Section shall expire
- 19 <u>according to the multi-year procedure established by Section</u>
- 20 <u>3-414.1 of this Code.</u>
- 21 (b) The design and color of the plates is wholly within
- 22 the discretion of the Secretary, except that the following
- 23 phrases shall be on the plates: (i) "Stop Neuroblastoma" and
- 24 (ii) "Stop Cancer". The Secretary may allow the plates to be
- 25 <u>issued as vanity plates or personalized under Section 3-405.1</u>
- of this Code. The Secretary shall prescribe stickers or
- 27 <u>decals as provided under Section 3-412 of this Code.</u>
- 28 (c) An applicant for the special plate shall be charged
- 29 <u>a \$25 fee for original issuance in addition to the</u>

- 1 appropriate registration fee. Of this fee, \$10 shall be
- 2 <u>deposited into the Stop Neuroblastoma Fund and \$15 shall be</u>
- 3 <u>deposited into the Secretary of State Special License Plate</u>
- 4 Fund, to be used by the Secretary to help defray the
- 5 <u>administrative processing costs.</u>
- 6 For each registration renewal period, a \$25 fee, in
- 7 <u>addition to the appropriate registration fee, shall be</u>
- 8 charged. Of this fee, \$23 shall be deposited into the Stop
- 9 Neuroblastoma Fund and \$2 shall be deposited into the
- 10 <u>Secretary of State Special License Plate Fund.</u>
- 11 (d) The Stop Neuroblastoma Fund is created as a special
- 12 <u>fund in the State treasury. All money in the Stop</u>
- 13 <u>Neuroblastoma Fund shall be paid, subject to appropriation by</u>
- 14 the General Assembly and approval by the Secretary, as grants
- 15 <u>to the American Cancer Society for neuroblastoma and cancer</u>
- research, education, screening, and treatment.
