# Report of Activities for State FY2021 and Projected Activities for State FY2022

Pursuant to the Illinois Housing Development Act, 20 ILCS 3805/5 et seq. ("Act"), the Illinois Housing Development Authority ("Authority") submits this report on its activities for the fiscal year ending on June 30, 2021 ("FY2021").

This report is broken down into four (4) parts. Part One lists all applications received by the Authority in SFY2021. Part Two reports on the Authority's financing activities around the State of Illinois ("State") during that time period. Part Three reports on the Authority's projected activities for FY2022. Part Four reports on the activities of the Strategic Planning and Reporting Department ("SPAR").

The Authority administers the following programs: the Illinois Affordable Housing Trust Fund ("Trust Fund"), the HOME Investment Partnerships Program ("HOME Program"), the federal Housing Trust Fund (HTF), the 1st Homelllinois program, Opening Doors program, SmartBuy program, Access Programs (including Access 4%, Access 5% and Access 10%) single family mortgage financing, Abandoned Properties Program ("APP"), Strong Communities Program ("SCP"), Land Bank Capacity Program and Technical Assistance Network ("LBCP"), the Foreclosure Prevention Program ("FPP"), Foreclosure Prevention Program - Graduated Fund ("FPPG"), Cook County Mortgage Foreclosure Mediation Program "CCMFMP"), the Emergency Rental Assistance and Emergency Mortgage Assistance Program, the Illinois Rental Payment program ("ILRPP"), the Rental Housing Support Program ("RHS Program") and the national Housing Trust Fund program ("HTF"). The Authority also administers the State Illinois Affordable Housing Tax Credit (IAHTC) and federal Low Income Housing Tax Credit (LIHTC) Programs. In FY2021 IHDA launched the Emergency Rental Assistance, Emergency Mortgage Assistance, and Illinois Rental Payment Program assistance programs statewide to promote housing stability during the COVID-19 pandemic.

#### **APPLICATIONS RECEIVED IN FY2021**

The Authority received a total of 9,682 applications seeking a total of \$814,703,577 in Federal and State resources in FY2021. These applications were for the creation or preservation of 4,376 units to the state. The Authority also received more than 168,000 applications seeking emergency assistance through the Emergency Rental Assistance, Emergency Mortgage Assistance, and Illinois Rental Payment Program assistance programs. All eligible and complete applications for emergency assistance were approved and funded. The remaining 88 applications received by the Authority in FY2021 sought 141,028,145 in State and Federal Tax Credit allocations, from IHDA. These applications were for the creation of an additional 6,612 residential units to the state.

#### **Bonds**

The Authority received 22 applications seeking \$598,112,568 to construct 3,575 units of housing through its bond financing programs. Of these bond applications, \$74,640,000 was requested through the Advantage Plus Mortgage and FFB Program. See EXHIBIT I.

#### **Illinois Affordable Housing Trust Fund**

The Authority received a total of 18 applications seeking \$88,521,409 in financing that, if awarded, would have provided an additional 589 units of housing for the state. Fourteen of these applications were submitted through the Permanent Supportive Housing Program. All of the applications received were for multi-family housing. See EXHIBIT II.

The Authority's Single Family Trust Fund (Trust Fund) programs are housed in the Community Affairs Department. In FY 2021, active programs consisted of the Community Impact Loan Fund - Habitat for Humanity, the Home Accessibility Program, the Single Family Rehabilitation Program, the Chicago Rehab Network Technical Assistance Grant, and the Land Bank Technical Assistance Program Grant. Active programs have a two-year funding cycle. In FY2021, 23 applications totaling \$ \$7,184,651 in grant requests were received by IHDA. Funding information for individual active programs can be found below.

#### **Home Accessibility Program**

An application funding round was held for the third round of this program in FY 2021, which received 14 applications totaling \$5,092,969 in grant requests. See EXHIBIT III.

#### **Single Family Rehabilitation Program**

In FY 2021, an application funding round was held for the second tranche of Disaster Contingency Award Component funding under the third round of the program. A total of 9 applications were received from existing Round 3 grantees, totaling \$2,091,682 in grant requests. See EXHIBIT IV.

#### **Community Impact Loan Fund – Habitat for Humanity**

The applicant applies periodically as part of the funding approval process for this program.

#### **Chicago Rehab Network Technical Assistance Grant**

The applicant applies periodically as part of the funding approval process for this program.

#### **Land Bank Technical Assistance Program Grant**

The Technical Assistance Providers apply periodically as part of the funding approval process for this program

#### **HOME Investment Partnership Program**

The HOME Program was created under Title II of the National Affordable Housing Act of 1990, as amended and authorized by the Housing and Community Development Act of 1992. The Authority received a total of 6 applications to its HOME Program. These applications sought a total of \$14,919,010 in financing to fund 151 units of affordable housing. All of the applications were submitted for the construction of multifamily housing. See EXHIBIT V.

#### **Tax Credit Programs**

The Authority's Tax Credit Programs received 88 applications for consideration. Of these applications, 72 applications were submitted for the federal Low Income Housing Tax Credit ("Federal Tax Credit") seeking a total of 126,472,917 in Federal Tax Credit allocations. See EXHIBIT VI. If funded, these projects would have provided an additional 5,898 units of affordable housing. The remaining 16 applications were submitted for the Illinois Affordable Housing Tax Credit ("State Tax Credit") seeking a total of 14,555,228 in State Tax Credit allocations that, if approved, would have assisted the creation of 714 units of affordable housing. See EXHIBIT VII.

#### **Homeowner Financed Mortgages**

During FY2021, the Authority, under its Homeownership Programs received applications for 9,332 loans totaling \$1,489,965,758 in first mortgages. A total of 9,320 of these applicants also applied for down payment assistance totaling \$46,882,388. A description of each Homeownership Program follows:

#### 1<sup>st</sup>Homelllinois

IHDA launched the 1stHomelllinois loan program in August 2015. 1stHomelllinois targets homeownership down payment assistance in ten Illinois counties hit hard by the foreclosure crisis. The following were the initial ten targeted counties: Boone, Cook, DeKalb, Fulton, Kane, Marion, McHenry, St. Clair, Will, and Winnebago. IHDA targeted these counties as they were above the state average in distressed housing market indicators such as delinquency rates, negative equity, and foreclosure rates. On January 1, 2019, the counties were reduced to four counties: Cook, Marion, St. Clair, and Winnebago. After analysis, the other 6 six counties showed improvement in the aforementioned distressed housing market indicators. The program provides \$7,500 in down payment assistance for a secure, 30-year fixed rate mortgage. During FY2021, the 1stHomelllinois program accounted for 652 applications, or 7%, of the department's first mortgage applications, totaling \$99,765,735 in first mortgages. Of these, 652, or 100%, applied for down payment assistance in the form of a second mortgage, totaling \$3,712,500. IHDA stopped taking reservations for the 1stHomelllinois program in Q2 2020.

#### Access 4%

Access Mortgage became the Illinois Housing Development Authority's flagship mortgage financing program on February 1, 2018. This consists of three programs. The first, Access 4% is designed to increase home purchase accessibility by offering a forgivable second mortgage of 4% of the purchase price (up to \$6,000) in down payment and/or closing cost assistance with a 30-year fixed rate first mortgage to qualified households across Illinois. Additionally, a Mortgage Credit Certificate , which entitles homebuyers to use 25% of yearly mortgage interest as a federal tax credit was available for eligible borrowers using this program starting September 1, 2018. The entire Access Mortgage program runs statewide for both first-time and non-first-time homebuyers. During FY2021, the Access 4% Program accounted for 2,806 applications, or 30%, of the department's first mortgage applications, totaling \$421,380,623 in first mortgages. Of these, 2,806 or 100%, applied for down payment assistance in the form of a second mortgage, totaling \$11,554,236. Of the 2,806 applications, 1 or 0.04%, also applied for the mortgage credit certificate (MCC) totaling \$54,000.

#### Access 5%

Access Mortgage became the Illinois Housing Development Authority's flagship mortgage financing program on February 1, 2018. This consists of three programs. The second, Access 5% is designed to increase home purchase accessibility by offering a repayable second mortgage of 5% of the purchase price (up to \$7,500) in down payment and/or closing cost assistance with a 30-year fixed rate first mortgage to qualified households across Illinois. Repayment will be deferred for 30 years, unless repaid sooner, or in the event of a refinance or sale of the property, at which time the funds will become due. Additionally, a Mortgage Credit Certificate, which entitles homebuyers to use 25% of yearly mortgage interest as a federal tax credit was available for eligible borrowers using this program starting September 1, 2018. The entire Access Mortgage program runs statewide for both first-time and non-first-time Homebuyers. During FY2021, the Access 5% Program accounted for 1,116 applications, or 12%, of the department's first mortgage applications, totaling \$203,303,352 in first mortgages. Of these, 1,116 or 100%, applied for down payment assistance in the form of a second mortgage, totaling \$5,973,002. Of the 645 applications, 0, or 0%, also applied for the mortgage credit certificate (MCC) totaling \$0.00.

#### Access 10%

Access Mortgage became the Illinois Housing Development Authority's flagship mortgage financing program on February 1, 2018. This consists of three programs. The third, Access 10% is designed to increase home purchase accessibility by offering a repayable second mortgage of 10% of the purchase price (up to \$10,000) in down payment and/or closing cost assistance with a 30-year fixed rate first mortgage to qualified households across Illinois. Repayment of the second is monthly, amortizing over a 10-year period at 0% interest rate. Additionally, a Mortgage Credit Certificate, which entitles homebuyers to use 25% of yearly mortgage interest as a federal tax credit was available for eligible borrowers using this program starting September 1, 2018. The

entire Access Mortgage program runs statewide for both first-time and non-first-time Homebuyers. During FY2019, the Access 10% Program accounted for 974 applications, or 9%, of the department's first mortgage applications, totaling \$179,057,649 in first mortgages. Of these, 974, or 100%, applied for down payment assistance in the form of a second mortgage, totaling \$7,375,955. Of the 974 applications, 0 or 0%, also applied for the mortgage credit certificate (MCC) totaling \$0.00.

#### I-Refi

IHDA launched the I-Refi program in August 2016. The program is designed to help homeowners who have been current on their mortgage payments for at least twelve months and are at least 110% underwater on their current mortgage. I-Refi offers up to \$50,000\* in federal assistance, funded through the U.S. Department of Treasury's Hardest Hit Fund (HHF), to buy down a mortgage and refinance into an affordable 30-year fixed rate mortgage. During FY2021, the I-Refi program accounted for 1 applications, or 0.01%, of the department's first mortgage applications, totaling \$258,236 in first mortgages. Of these, 1, or 100%, applied for down payment assistance totaling \$45,695. IHDA stopped taking reservations for the I-Refi program in Q2 2020.

\*Borrowers who have previously utilized HHF may be eligible for an additional \$35,000 for a total of \$85,000.

#### **Opening Doors**

The Authority launched the Opening Doors program on December 1, 2020. Opening Doors offers a second mortgage of \$6,000 in down payment and/or closing cost assistance forgiven monthly over 5 years with a 30-year fixed rate first mortgage to qualified households across Illinois. During FY2021, the Opening Doors program accounted for 3,045 applications, or 33%, of the department's first mortgage applications, totaling \$429,390,446 in first mortgages. Of these, 3,045, or 100%, applied for down payment assistance totaling \$15,126,000.

#### **SmartBuy**

The Authority launched the SmartBuy program on December 1, 2020, to assist homebuyers affected by increasing student loan debt with purchasing a home in Illinois. SmartBuy offers student loan debt relief provided in the form of a promissory note (up to 15% of the purchase price, not to exceed \$40,000) that is forgiven monthly over 3 years. SmartBuy also offers a repayable second mortgage of \$5,000 in down payment and/or closing cost assistance with a 30-year fixed rate first mortgage to qualified households across Illinois. Repayment of the second mortgage will be deferred for 30 years, unless repaid sooner, or in the event of a refinance or sale of the property, at which time the funds will become due. During FY2021, the SmartBuy program accounted for 738 applications, or 8%, of the department's first mortgage applications, totaling \$156,809,717 in first mortgages. Of these, 726, or 98%, applied for down payment assistance totaling \$3,095,000, while 100% of the 738 received the grant assistance totaling \$16,820,495.25.

#### **Housing Counseling Programs**

On behalf of the Authority, the Community Affairs Department administers programs which provide operational and capacity building funding to HUD approved housing counseling agencies and community-based organizations, which supports housing counseling, financial literacy, and organizational capacity building across the state. In FY 2021, the Authority received a combined 80 applications totaling \$8.14 million in grant requests. Funding information for individual active programs can be found below.

#### **Foreclosure Prevention Program**

Section 7.30 of the Save our Neighborhoods Act (P.A. 96-1419), designates the Authority as the administrator of FPP, to provide grants to HUD-approved counseling agencies and non-profit community-based organizations for foreclosure prevention counseling, pre- and post- purchase counseling, counselor training and capacity-building. The program is funded via plaintiff-paid foreclosure filing fees. Though active in FY 2021, no application funding rounds were held for this program. As a result of the Illinois Supreme Court's decision in

Walker v. Chasteen, which found the program's funding mechanism to be unconstitutional, no future application funding rounds are planned for this program.

#### Foreclosure Prevention Program Graduated Fund

Created under SB 16 in the 97th General Assembly and codified as PA 097-1164 20ILCS 3805/7.30. Under this program, IHDA makes grants to HUD-approved counseling agencies for all activities required to successfully manage a housing counseling program including training, pre- and post- purchase counseling, rental counseling, foreclosure prevention counseling and credit counseling. The program is funded via plaintiff-paid foreclosure filing fees. Though active in FY 2021, no funding rounds were held for this program. As a result of the Illinois Supreme Court's decision in Walker v. Chasteen, which found the program's funding mechanism to be unconstitutional, no future application funding rounds are planned for this program.

#### **Community Outreach and Assistance Programs**

The Community Outreach and Assistance grants made in connection with the Authority's Coronavirus Relief Program funds are funded by the State Coronavirus Urgent Remediation Emergency Fund (IL CURE FUND), which was established by the Coronavirus Aid, Relief, and Economic Security Act (the CARES Act), signed into law on March 27, 2020, and created, through Section 5001 of the CARES Act, the Coronavirus Relief Fund (CRF). COA funds housing counseling agencies, community-based organizations, and non-profit organizations including legal assistance groups to assist with the administration of the Emergency Mortgage Assistance (EMA) and the Emergency Rental Assistance (ERA) programs, which are also funded by the IL CURE FUND. The COA grant recipient's core responsibilities include assisting Illinois residents with disseminating EMA/ERA information and outreach, assisting the client with the online application process, and assisting those whose income has been impacted by COVID-19. Though active, the Authority did not approve an application funding round for the program in FY 2021. No additional application funding rounds are anticipated for this program.

#### Housing Stability Services (HSS) for the Illinois Rental Payment Program (ILRPP)

This program was funded by the U.S. Department of Treasury under the Consolidated Appropriations act of 2021. The Illinois Department of Commerce and Economic Opportunity (DCEO) applied to the U.S. Treasury on behalf of Illinois and was awarded funds. DCEO then sub-granted a portion of the IL ERA Award to IHDA in connection with the operation of the ILRPP and the HSS agency partners. HSS agencies were utilized to assist with administering the ILRPP by conducting outreach and intake for the rental assistance component. In FY 2021, IHDA held an application funding round (Round 1.0), which received 72 applications totaling \$8.14 million in grant requests. See EXHIBIT VIII.

Future application funding rounds are anticipated for this program, following its administrative transfer to IHDA's Strategic Response Department(SRU), on February 1, 2022.

#### **Cook County Mortgage Foreclosure Mediation Program**

The program was first established in 2010 in response to the economic recession and related mortgage crisis which began in 2008. The program was designed to provide Cook County homeowners in foreclosure with critical support and to help them explore their options to either stay in their homes or negotiate a respectable exit as early as possible once the foreclosure process begins. IHDA manages the helpline and housing counseling agency components of the grant. This initial iteration of the program ceased activity in 2017 but was reopened in 2021 as a response to the risk of rising foreclosures due to the COVID-19 pandemic. IHDA held an application funding round in FY 2021 (Round 6), which received 8 applications from Cook County organizations seeking to enter into fee for service agreements under the program. See EXHIBIT IX.

#### **Community Revitalization Programs**

On behalf of the Authority, Community Affairs administers a series of programs aimed at providing funding and technical assistance to Illinois units of local government, including land banks, to support community revitalization measures

aimed at addressing vacant and/or abandoned distressed residential properties. In FY 2021, active programs consisted of the Abandoned Properties Program, Land Bank Capacity Program and Technical Assistance Network, and the Strong Communities Program. In FY 2021, 196 applications were received by the Authority, totaling \$32.3 million in combined grant requests. Funding information for individual active programs can be found below.

#### **Abandoned Properties Program**

In August 2010, the Save our Neighborhoods Act (P.A. 96-1419) was passed into law, creating the Abandoned Residential Property Municipality Relief Fund. Sufficient funds were not generated for the program until the passage of SB16 in the 97th General Assembly. Codified as PA 097-1164, 20 ILCS 3805/7.31, which changed the plaintiff-paid foreclosure filing fee structure, and fund contribution formula. Under this program, IHDA makes grants to municipalities and counties to assist with costs they incur to secure, maintain, or demolish abandoned residential properties within their jurisdictions, to assist with revitalization efforts. In FY 2021, IHDA held an application funding round (Round 5), which received 102 applications, totaling \$13.6 million in grant requests. See EXHIBIT X. As a result of the Illinois Supreme Court's decision in Walker v. Chasteen, which found the program's funding mechanism to be unconstitutional, no future rounds are planned from this funding source.

#### Land Bank Capacity Program and Technical Assistance Network

The Land Bank Capacity Program and Technical Assistance Network assists communities statewide, outside of the Chicago metropolitan area, with an emphasis on downstate and southern Illinois communities, by providing grant funds to help empower local and regional revitalization efforts through increased planning and land bank capacity. Funds are provided to units of local government and to technical assistance providers for initial capital to fund start-up costs of creating a land bank, operating costs, costs for land acquisition and other locally managed revitalization techniques. The technical assistance component of the grant is dedicated to increasing development capacity for those communities seeking to form land banks. Funding is derived solely from a national settlement secured by the Illinois' Attorney General, in conjunction with other state attorneys general, the U.S. Department of Justice and the U.S. Department of Housing and Urban Development with the nation's largest banks. Though active, IHDA did not hold an application funding round for the program in FY 2021.

#### Strong Communities Program

The Strong Communities Program was established with \$30,000,000 of the total \$200,000,000 in funds appropriated from the Build Illinois Bond Fund to the Department of Revenue for the Illinois Housing Development Authority. SCP will provide grant funds to units of local government throughout the state, to address local affordable housing needs and community revitalization efforts. The Program aims to return vacant residential properties to productive and taxable use through rehabilitation, and it provides funds for demolition in cases where properties are beyond repair and negatively impacting neighboring residences. As a result, SCP will increase property values, create jobs, help reduce crime, generate additional tax revenue, and attract further community investment. In FY 2021, IHDA released the first application funding round for SCP, which received 94 applications, totaling \$18.7 million in grant requests. See EXHIBIT XI.

#### Rental Housing Support Program

The Rental Housing Support Program or "RHSP" was signed into law through Public Act 94-118, the Rental Housing Support Program Act, to create a rental assistance program for severely low-income households in the state. RHSP is divided into two sub-programs: (i) the Rental Housing Support Program, which allows the Authority to contract with agencies throughout the State called Local Administering Agencies ("LAAs"); and (ii) the Long Term Operating Support Program (the "LTOS Program"), which allows the Authority to directly contract with owners of rental developments. Funding for the two programs is allocated based on a formula in the enabling legislation.

The RHS-LAA Program renewed 11 contracts in FY 2021 to continue participation in the program. Contract requests for funding totaled \$11,623,551, representing an estimated 323 units that would be assisted throughout the state.

#### **National Housing Trust Fund**

NHTF was established as a permanent federal program, with dedicated sources of funding coming from a percentage of after-tax profits from the Government Sponsored Enterprises (GSEs) Fannie Mae and Freddie Mac, which are not subject to the appropriations process. The Authority received a total of 2 applications seeking \$7,020,000 in financing that, if awarded, would have provided an additional 61 units of housing for the state. All of the applications received were for multi-family housing.

#### **Other Financing Requests**

IHDA received 33 requests for \$67,000,847 in gap financing that would generate 1,688 in affordable units if funded. These other financing requests represent a subordinate resource request. This funding depends on the availability of funds in various programs including, HOME, Trust Fund, Bond, FAF, National Housing Trust Fund, State Tax Credits, and Federal Tax Credits. See Exhibit XII.

#### **COVID-Related Emergency Funding**

The Emergency Rental Assistance (ERA) and Emergency Mortgage Assistance (EMA) programs were created with State of Illinois CARES Act funding in response to the economic crisis caused by the COVID-19 pandemic. Renters who were impacted by COVID-19 and subsequently behind on their rent were awarded \$5,000 in rental assistance to cover past due rent and future rent from March 2020 through December 2020. Impacted mortgage holders received up to \$25,000 in assistance to pay past due mortgage debt and future mortgage payments through December 2020 to avoid foreclosure risk. The ERA and EMA programs launched in August 2020, at the beginning of the State FY 2021. ERA received 79,267 unique applications, and fully funded all 46,129 eligible and complete applicants after a review process in which IHDA worked with applicants to help correct or complete their applications. Over 67% of approved applicants were from households who identified as either African American, American Indian, Asian, or Pacific Islander, and they received over \$155 million in assistance. African American households received the largest share (63%) of funding. EMA received and fully funded more than 10,000 eligible and complete applicants after a review process in which IHDA worked with applicants to help correct or complete their applications. Both ERA and EMA programs approved all eligible and complete applicants by December 31, 2020.

Using federal Consolidated Appropriations Act of 2021, the Illinois Rental Payment Program (ILRPP) was launched in May 2021, to provide a lifeline for renters and landlords who continued to experience financial hardships related to the COVID-19 Pandemic. Per program rules, payments could cover missed rent payments as far back as June 2020 and prepay rent through August 2021, or until the \$25,000 was exhausted, whichever came first. IHDA received 78,681 applications from the program's opening through the end of the fiscal year on June 30, 2021 (the program continued to accept applications through August 2021).

#### FINANCING ACTIVITIES IN FY2021

#### **Bonds**

During FY2021, the Authority financed approximately \$301,990,730 for first mortgage loans on 14 multi-family developments located in the State. These developments were financed through the Authority's Conduit Bond, Tax Exempt Bond, and Advantage Mortgage Programs, and contain a total of 2,377 units. See EXHIBIT XIII.

#### Illinois Affordable Housing Trust Fund

During FY2021, the Trust Fund received \$44,187,683 from its portion of the proceeds of the Illinois real estate transfer tax. This amount was approximately \$5,721,153 more than the amount received in FY2020. There were 18 Multifamily Trust Fund projects approved by the Authority's Board in FY2020 for approximately \$33,006,366, assisting to create 732 units. See EXHIBIT XIV.

In FY 2021, Single Family Trust Fund supported funding under the Community Impact Loan Fund Program - Habitat for Humanity, Home Accessibility Program, Single Family Rehabilitation Program, the Chicago Rehab Network Technical Assistance Grant, and the Land Bank Technical Assistance Program Grant. A combined \$3,364,237.21 was disbursed to assist 104 households along with providing technical assistance support across the programs. Financing information for individual active programs can be found below.

#### **Community Impact Fund - Habitat for Humanity**

In FY 2021, \$330,000 was disbursed to assist 18 low-income qualified homebuyers under Round 4 of the program.

#### **Home Accessibility Program**

In FY 2021, \$315,665.05 was disbursed to assist 16 households under Round 2. Additionally, in FY 2021, a combined \$3 million was awarded to 11 organizations under Round 3 of the program. See EXHIBIT XV.

#### Single Family Rehabilitation Programs

In FY 2021, a combined \$2,541,589.31 was disbursed to assist 70 households under Rounds 2 and 3 of the program. Additionally, \$1 million was awarded to 9 existing Round 3 grantees, as part of the second tranche of the program's Disaster Contingency Award Component funds. See EXHIBIT XVI.

#### Technical Assistance Grant (Chicago Rehab Network)

In FY 2021, \$155,247.85 was disbursed to provide technical assistance and training under Rounds 2 and 3 of the program.

#### **Land Bank Technical Assistance Program Grant**

In FY 2021, a combined \$400,000 was awarded to the two existing Land Bank Capacity Program and Technical Assistance Network, technical assistance providers. See EXHIBIT XVII. A total of \$20,745.00 was disbursed to provide technical assistance under Round 1 of the program.

#### **Homes for a Changing Region**

The Trust Fund also finances a Homes for a Changing Region initiative that provides technical assistance and plan-making resources for local municipalities to update their community housing plans. The Homes for a Changing Region – Phase 2 initiative disbursed \$76,048 in funding and created three community housing plans with partner municipalities in FY2021.

#### **HOME Program**

During FY2021, the Authority closed HOME loans totaling approximately \$10,365,856 for 4 multi-family housing developments. A total of 162 HOME units in two counties will be assisted through the loans made during FY2021. See FXHIBIT XVIII.

#### **Tax Credit Programs**

#### **Federal Low Income Housing Tax Credits**

During FY2021, the Authority approved and allocated approximately 16,788,045 in Federal Tax Credits totaling approximately \$147,942,707 (over 10 years/discounted). These developments contain a total of 820 units, of which 819 units are reserved for low-income households. Federal Tax Credit allocations were used in conjunction with several of the Authority's programs, including the HOME Program, Trust Fund, and State Tax Credit allocations. In addition, tax-exempt bond deals allocated a total of 19,597,720 in Federal (4%) Tax Credits, totaling approximately \$186,835,253, and creating 3,037 units, 2,759 of which were designated for low income residents. See EXHIBIT XIX.

#### State Tax Credits (Illinois Affordable Housing Tax Credits)

During FY2021, the Authority approved and allocated approximately 19,984,538 in State Tax Credits. These developments are expected to contain a total of 1,001 units, of which 258 units are reserved for low-income households. State Tax Credit allocations were used in conjunction with several of the Authority's programs including the HOME Program, Trust Fund, and Federal Tax Credit allocations. See EXHIBIT XX.

#### **Homeowner Financed Mortgages FY2021**

During FY2021, the Authority, under its homeownership programs purchased and provided loans for first-time and non-first-time homebuyers. Under this program, the Authority purchased 7,361 loans in 85 of the State's 102 counties totaling \$1,137,492,413 in first mortgages. The breakdown of each homeownership program is as follows:

#### 1<sup>st</sup>Homelllinois

During FY2021, the Authority's 1stHomelllinois program provided \$82,283,448 in first mortgages to 556 households, or 8% of the program's financing.

#### Access 4%

During FY2021, the Authority's Access 4% program provided \$459,670,677 in first mortgages to 3,147 households, or 43% of the program's financing.

#### Access 5%

During FY2021, the Authority's Access 5% program provided \$177,784,442 in first mortgages to 989 households, or 13% of the program's financing.

#### Access 10%

During FY2021, the Authority's Access 10% program provided \$137,151,548 in first mortgages to 775 households, or 11% of the program's financing.

#### I-Refi

During FY2021, the Authority's I-Refi program provided \$258,236 in first mortgages to 1 households, or 0.01% of the program's financing.

#### **Opening Doors**

During FY2021, the Authority's Opening Doors program provided \$216,937,876 in first mortgages to 1,587 households, or 22% of the program's financing.

#### **SmartBuy**

During FY2021, the Authority's SmartBuy program provided \$63,406,186 in first mortgages to 306 households, or 4% of the program's financing

#### **Housing Counseling Programs**

In FY 2021, IHDA continued funding disbursements under its housing counseling programs, to provide operational and capacity building support to HUD approved housing counseling agencies and community-based organizations, in support of housing counseling, financial literacy, and organizational capacity building. This was especially important considering the ongoing impacts of the COVID-19 pandemic. Active programs included the Foreclosure Prevention Program, Foreclosure Prevention Program Graduated, Community Outreach and Assistance Program, and Housing Stability Services for the Illinois Rental Payment Program. In FY 2021, a combined \$8.1 million dollars was disbursed to assist 24,761 households with counseling, 110,093 approved applications for rental assistance, and 10,071 approved applications for mortgage assistance. Financing information for individual active programs can be found below.

#### **Foreclosure Prevention Program**

The Foreclosure Prevention Program (FPP), established by 20 ILCS 3805/7.30, provides grants to HUD-approved Housing Counseling Agencies and Community Based Organizations (CBOs). FPP is funded via foreclosure filing fees paid by plaintiffs to the respective County Clerk. FPP is a reimbursement program for funds already expended by participating agencies for eligible uses. Eligible activities include financial literacy, pre- and post-purchase counseling, foreclosure counseling, staff/counselor training, capacity building, and operational expenses. Funds disbursed under FPP in FY 2021 totaled \$1,556,906.08, assisting 8,609 households. No funding awards were given under the program in FY 2021.

#### **Foreclosure Prevention Program Graduated Fund**

The Foreclosure Prevention Program Graduated Fund (FPP-G), established by 20 ILCS 3805/7.30(b-1), provides grants to HUD-approved Housing Counseling Agencies. FPP-G is funded via foreclosure filing fees paid by plaintiffs to the respective County Clerk. FPP-G is a reimbursement program for funds already expended by the agencies for eligible uses. Eligible activities include financial literacy, pre- and post-purchase counseling, foreclosure counseling, staff/counselor training, capacity building, and operational expenses. Disbursements under FPP-G in FY 2021, were \$2,894,177.62, serving 16,152 households. No funding awards were given under the program in FY 2021.

#### **Community Outreach and Assistance Program**

The Community Outreach and Assistance grants made in connection with the Authority's Coronavirus Relief Program Funds are funded by the State Coronavirus Urgent Remediation Emergency Fund (IL CURE FUND), which was established by the Coronavirus Aid, Relief, and Economic Security Act (the CARES Act), signed into law on March 27, 2020, and created, through Section 5001 of the CARES Act, the Coronavirus Relief Fund (CRF). COA funds housing counseling agencies, community-based organizations, and non-profit organizations including legal assistance groups to assist with the administration of the Emergency Mortgage Assistance (EMA) and the Emergency Rental Assistance (ERA) programs, which are also funded by the IL CURE FUND. The COA grant recipient's core responsibilities include assisting Illinois residents with disseminating EMA/ERA information and outreach, assisting the client with the online application process, and assisting those whose income have been impacted by COVID-19. In FY 2021, a combined \$3.02 million in funds were awarded to 66 organizations. See EXHIBIT XXI. Additionally, \$2,405,243.36 million was disbursed to support a final total of 56,200 approved applications for CRF funding (certified at program close). This included 46,129 for Emergency Rental Assistance, and 10,071 for Emergency Mortgage Assistance.

#### Housing Stability Services (HSS) for the Illinois Rental Payment Program

This program was funded by the U.S. Department of Treasury under the Consolidated Appropriations act of 2021. The Illinois Department of Commerce and Economic Opportunity (DCEO) applied to the U.S. Treasury on

behalf of the Illinois and was awarded funds. DCEO then granted a portion of the IL ERA Award to IHDA in connection with the operation of the ILRPP and the HSS agency partners. HSS agencies were utilized to assist with administering the ILRPP by conducting outreach and intake for the rental assistance component. In FY 2021, IHDA awarded a combined \$6.3 million to 64 organizations under Round 1.0 of the program. See EXHIBIT XXII. Additionally, a combined \$1,274,807.02 was disbursed to support a final total of 63,964 approved applications for rental payment assistance (certified at program close). Future application funding rounds are anticipated for this program, following its administrative transfer to IHDA's Strategic Response Department (SRU), on February 1, 2022.

#### **Community Revitalization Programs**

On behalf of the Authority, Community Affairs administers a series of programs aimed at providing funding and technical assistance to Illinois units of local government, including land banks to support community revitalization measures aimed at addressing vacant and/or abandoned distressed residential properties. In FY 2021, active programs consisted of the Abandoned Properties Program, Blight Reduction Program, the Land Bank Capacity Program and Technical Assistance Network, and the Strong Communities Program. A combined \$6,077,672.45 was disbursed to assist 1,337 properties. Financing information for individual active programs can be found below.

#### **Abandoned Properties Program**

APP assists units of local government with costs incurred for securing, maintaining, or demolishing vacant and abandoned residential properties to assist with revitalization efforts across the state. In FY 2021, the Authority awarded a combined \$7.3 million to 57 organizations. See EXHIBIT XXIII. Additionally, IHDA disbursed a total of \$5,442,614.12 to finance revitalization activities on 1,309 unique properties under Rounds 3 and 4 of the program.

#### **Blight Reduction Program**

In FY 2021, the Authority continued to disburse funds under BRP Round 2. Funding helped units of local government and their not-for profit partners, target areas with vacant and abandoned residential properties in need of demolition and greening. A total of \$168,377.82 was disbursed to fund the demolition of 6 properties.

#### Land Bank Capacity Program and Technical Assistance Network

LBCP provides funds to units of local government and technical assistance providers for initial capital to fund start-up costs of creating a land bank, operating costs, costs for land acquisition and other locally managed revitalization techniques. The technical assistance component available in Round 1, is dedicated to increasing development capacity for those communities seeking to form land banks. In FY 2021, IHDA disbursed a combined \$466,680.51 to support revitalization activities on 22 properties in addition to technical assistance for program grantees.

#### **Strong Communities Program (SCP)**

The Strong Communities Program was established with \$30,000,000 of the total \$200,000,000 in funds appropriated from the Build Illinois Bond Fund to the Department of Revenue for the Illinois Housing Development Authority. SCP will provide grant funds to units of local government throughout the state, to address local affordable housing needs and community revitalization efforts. The Program aims to return vacant residential properties to productive and taxable use through rehabilitation, and it provides funds for demolition in cases where properties are beyond repair and negatively impacting neighboring residences. As a result, SCP will increase property values, create jobs, help reduce crime, generate additional tax revenue, and attract further community investment. In FY 2021, IHDA awarded a combined \$10 million to 68 grantees. See EXHIBIT XXIV.

#### **Rental Housing Support Program**

During FY 2021, the RHS Program received \$18,758,964 from the proceeds of real estate document recording fees. The funds are allocated based on a method outlined in the enabling legislation, which allows for four geographic areas in the State: City of Chicago, Metro Chicago, Small Metro Areas, and Rural Areas. Each area gets a proportionate share of the funds based on its proportion of households at or below 50% AMI, and who are spending 30% or more of the income on rent and utilities. In FY 2021, the Authority renewed contracts with 11 LAAs (as defined in Section I-M above), for a total of \$11,623,551 in funding, representing 323 units. See EXHIBIT XXV. There was one award of LTOS funds in SFY 2021 totaling \$1,207,772.

#### **National Housing Trust Fund**

The National Housing Trust Fund (NHTF) was authorized as part of the Housing and Economic Recovery Act of 2008 and provides rental housing for ELI households at 30% or below area median income. The State of Illinois received \$8,575,518 for program year 20 19. IHDA is working towards closing current Board Approved applications.

#### **Other Financing Requests**

'Other' financing requests represent a subordinate resource request. This funding depends on the availability of funds in various programs including, HOME, Trust Fund, Bond, FAF, State Tax Credits, and Federal Tax Credits. See Exhibit XXVI.

#### **COVID-Related Emergency Funding**

The Emergency Rental Assistance and Emergency Mortgage Assistance programs were created with State of Illinois CARES Act funding in response to the economic crisis caused by the COVID-19 pandemic. Renters who were impacted by COVID-19 and subsequently behind on their rent were awarded \$5,000 in rental assistance to cover past due rent and future rent from March 2020 through December 2020. Impacted mortgage holders received up to \$25,000 in assistance to pay past due mortgage debt and future mortgage payments through December 2020 to avoid foreclosure risk. The ERA and EMA programs launched in August 2020, at the beginning of the State FY 2021. The programs approved all applicants by December 31, 2020. ERA assisted over 46,000 renter households with \$225 million dollars and EMA assisted over 10,000 households with \$100 million dollars.

Using federal Consolidated Appropriations Act of 2021, the Illinois Rental Payment Program (ILRPP) was launched in May 2021, to provide a lifeline for renters and landlords who continued to experience financial hardships related to the COVID-19 Pandemic. Per program rules, payments could cover missed rent payments as far back as June 2020 and prepay rent through August 2021, or until the \$25,000 was exhausted, whichever came first. By the end of the fiscal year on June 30, 2021, IHDA had already disbursed \$92,117,388.99 in funding to eligible applicants. The program continued accepting applications through August 2021, and funded all eligible applicants by December 2021.

#### PROJECTED ACTIVITIES FOR FY2022

#### **Bonds**

The Authority has already closed 14 loans approved by the Board in FY2021, providing 2,377 units of rental housing. The Authority anticipates bringing approximately 19 more projects to the Board in FY2022, which will provide approximately 2,020 additional units of rental housing. This includes Conduit Bond, Tax Exempt Bond, and Advantage Mortgage Programs.

#### Illinois Affordable Housing Trust Fund

The Authority will continue to serve as the State's administrator for the Affordable Housing Trust Fund. As program administrator, the Authority expects to continue its loan and grant activities in FY2022, although it does not plan to issue any new Trust Fund bonds. Based on the level of real estate sales in the State, the Trust Fund is expected to receive approximately \$45,000,000 of Real Estate Transfer Tax in FY2022 and it will be used to fund grant and loan applications received from around the state. The review of Trust Fund applications will continue to be based on the priorities and guidelines established by the Authority and the Trust Fund Advisory Commission.

The program preserves project-based rental subsidies in existing developments by encouraging owners who acquire and rehabilitate properties to extend existing rental subsidy contracts. The amount of subordinate funding to be provided under Preservation Now will be limited to approximately 10% of the total development costs or the amount necessary to make the project financially feasible, as determined by IHDA. Funding for this program is expected to come from bond cap and/or the Trust Fund.

In FY2022, non multi-family Trust Fund programs are listed below:

#### Community Impact Fund – Habitat for Humanity

In FY 2022, disbursement of funds under Round 4 of the program is set to end on February 28, 2022, however an extension of the program's term, until February 27, 2023 (FY 2023), was presented to and approved by the IHDA Board on January 21, 2022.

#### **Home Accessibility Program**

In FY 2022, disbursal of funds will continue under Rounds 2 and 3 of the program. Final payments under Round 2 are set to occur by the end of July 2022 (FY 2023), while payments under Round 3 are set to end on August 16, 2023 (FY 2024).

#### **Single Family Rehabilitation Program**

Disbursal of funds under Rounds 2 and 3 is expected to continue during FY 2022, with Round 2 activity slated to end on April 30, 2022, and Round 3 activity expected to end on July 14, 2022 (FY 2023).

#### **Technical Assistance Grant (Chicago Rehab Network)**

Disbursal of funds under Round 3 is expected to continue in FY 2022, with program activity planned to end on September 1, 2022 (FY 2023). Round 4 of the program is slated to begin in September of 2022 (FY 2023).

#### Land Bank Technical Assistance Program Grant (LBTA):

In FY 2022, the Authority is expected to continue disbursing funding under Round 1 of LBTA, with final program activity slated for December of 2022 (FY 2023).

#### **Homes for a Changing Region**

The Homes for a Changing Region – Phase 2 initiative disbursed \$76,048 in funding and created two community housing plans with partner municipalities in FY2022. The Homes for a Changing Region partners also were

approved for another round of funding in the amount of \$305,000 and expects to disburse funds in the amount of \$152,500 prior to the end of FY2022.

#### **HOME Investment Partnership Program**

The Authority will continue to serve as the State's designated administrator ("Participating Jurisdiction") of the federal HOME program. The amount of HOME funds allocated to the State FY2021 was \$16,742,680 and the Authority expects approximately \$17,000,000, per HUD's anticipated FY2022 allocation. In FY2022, the Authority will continue to make multifamily loans under the HOME Program to assist low and very low-income households.

#### **Tax Credit Programs**

#### **Federal Tax Credits**

The Authority will continue to serve as the State's administrator for Federal Tax Credit allocations. The Authority anticipates that a total of approximately \$35,000,000 in Federal Tax Credit allocations (with approximately \$7,500,000 allocated to the City of Chicago), to be disbursed in FY2022.

#### State Tax Credits (Illinois Affordable Housing Tax Credits)

The Authority will continue to serve as the State's administrator for State Tax Credit allocations. The Authority anticipates that a total of approximately \$ 32,850,000 in State Tax Credit allocations (with approximately \$8,048,000 allocated to the City of Chicago), to be disbursed in FY2022.

#### **Homeowner Financed Mortgages Projection FY2022**

In FY2022, the Authority anticipates financing approximately \$1.21 billion in first mortgages available to first-time and non-first-time homebuyers. Additionally, the Authority anticipates financing approximately \$58.24 million in second mortgages for down payment assistance and issuing \$0.00 million in Mortgage Credit Certificates (MCC's). During FY2022, the Authority anticipates assisting approximately 7,286 households.

#### 1<sup>st</sup>Homelllinois

The Authority launched the 1stHomelllinois program August 1, 2015. The program offers \$7,500 in down payment assistance within ten (10) designated counties throughout the State of Illinois. Effective January 1, 2019, 1stHomelllinois was only offered in four (4) of the original counties. The Authority anticipates funding \$37.33 million in first mortgages and \$4.18 million in second mortgages for down payment assistance during FY2021, assisting approximately 557 households through the 1stHomelllinois program. IHDA stopped taking reservations for the 1stHomelllinois program in Q2 2020.

#### Access 4%

Access 4% is designed to increase home purchase accessibility by offering a forgivable second mortgage of 4% of the purchase price (up to \$6,000) in down payment and/or closing cost assistance with a 30-year fixed rate first mortgage to qualified households across Illinois. The Authority anticipates funding \$522.95 million in first mortgages and \$18.14 million in assistance during FY2021, assisting approximately 3,575 households through the Access 4% program.

#### Access 5%

Access 5% is designed to increase home purchase accessibility by offering a repayable second mortgage of 5% of the purchase price (up to \$7,500) in down payment and/or closing cost assistance with a 30-year fixed rate first mortgage to qualified households across Illinois. Repayment will be deferred for 30 years, unless repaid sooner, or in the event of a refinance or sale of the property, at which time the funds will become due. The Authority anticipates funding \$233.08 million in first mortgages and \$9.09 million in assistance during FY2021, assisting approximately 1,304 households through the Access 5% program.

#### Access 10%

Access 10% is designed to increase home purchase accessibility by offering a repayable second mortgage of 10% of the purchase price (up to \$10,000) in down payment and/or closing cost assistance with a 30-year fixed rate first mortgage to qualified households across Illinois. Repayment of the second is monthly amortizing over a 10-year period at 0% interest rate. The Authority anticipates funding \$162.57 million in first mortgages and \$8.28 million in assistance during FY2022, assisting approximately 814 households through the Access 10% program.

#### **Opening Doors**

The Authority launched the Opening Doors program on December 1, 2020. Opening Doors offers a second mortgage of \$6,000 in down payment and/or closing cost assistance forgiven monthly over 5 years with a 30-year fixed rate first mortgage to qualified households across Illinois. The Authority anticipates funding \$643.73 million in first mortgages and \$27.07 million in assistance during FY2022, assisting approximately 4,879 households through the Opening Doors program.

#### **SmartBuy**

The Authority launched the SmartBuy program on December 1, 2020, to assist homebuyers affected by increasing student loan debt with purchasing a home in Illinois. SmartBuy offers student loan debt relief provided in the form of a promissory note (up to 15% of the purchase price, not to exceed \$40,000) that is forgiven monthly over 3 years. SmartBuy also offers a repayable second mortgage of \$5,000 in down payment and/or closing cost assistance with a 30-year fixed rate first mortgage to qualified households across Illinois. Repayment of the second mortgage will be deferred for 30 years, unless repaid sooner, or in the event of a refinance or sale of the property, at which time the funds will become due. The Authority anticipates funding \$87.48 million in first mortgages and \$12.06 million in assistance during FY2022, assisting approximately 365 households through the SmartBuy program.

#### **Foreclosure Prevention Program**

Funded via plaintiff-paid foreclosure filing fees, FPP provides funding to HUD-approved counseling agencies and community-based organizations for foreclosure prevention counseling, pre- and post-purchase counseling, counselor training, and capacity building. In FY 2022 to date, IHDA finalized activity under Round 7 of the program, with \$549,368.06 disbursed, and 877 households assisted. As a result of the Illinois Supreme Court's decision in Walker v. Chasteen, which found the program's funding mechanism to be unconstitutional, no future application funding rounds are planned for this program.

#### **Foreclosure Prevention Program Graduated Fund**

Funded via plaintiff-paid foreclosure filing fees, FPP-G provides funding to HUD-approved housing counseling agencies for all activities required to successfully manage a housing counseling program including training, pre- and post-purchase counseling, foreclosure prevention counseling, and financial counseling. In FY 2022 to date, IHDA finalized activity under Round 4 of the program, with \$617,465.87 disbursed, and 1,144 household assisted. As a result of the Illinois Supreme Court's decision in Walker v. Chasteen, which found the program's funding mechanism to be unconstitutional, no future application funding rounds are planned for this program.

#### **Abandoned Properties Program**

APP provides grants to municipalities and counties to assist with costs incurred for the securing, maintaining, or demolition of abandoned residential properties to assist units of local government with revitalization efforts. The Illinois Supreme Court issued an opinion in Walker v. Chasteen, on June 17, 2021 (FY 2021), ruling that the statutory framework funding the APP is unconstitutional. Final disposition of the underlying case remains pending in the circuit court of Will County. All APP activities are currently on pause, and grantees have been notified. Submissions were requested from all grantees in both Round 4 and Round 5 for expenses incurred through September 15, 2021. Payment for these submissions was approved in December of 2021, and payments were made on January 7, 2022 (FY 2022). The final APP

payment will be made by the end of February 2022. This payment will cover all expenses for parcels that were "in process" as of September 15, 2021 and incurred prior to January 31, 2022. Payments to date in FY 2022 total a combined \$ 5,071,404. Subject to the approval of the IHDA Board, IHDA intends to use a portion of the Capital Funds being administered by IHDA in connection with the Strong Communities Program (SCP) to replace the remaining unused portions of the APP Round 5 grant awards with Strong Communities Program grant awards. 48 APP R5 grantees requested replacement awards. Recommendations will be taken to IHDA's Board for consideration and approval at the planned February 2022 meeting. No future funding rounds are planned for APP.

#### **Blight Reduction Program**

No activity has occurred to date in FY 2022, under BRP, as the program fully closed in FY 2021, following the final disbursement of funds under Round 2 of the program. No additional rounds are planned for BRP.

#### **Community Outreach and Assistance Program**

Funded by the IL CURE FUND, as part of the CARES Act, the Community Outreach and Assistance grants in connection with the Authority's Coronavirus Relief Program funds housing counseling agencies, community-based organizations, and non-profit organizations including legal assistance groups to assist with the administration of the Emergency Mortgage Assistance (EMA) and the Emergency Rental Assistance (ERA) programs, which are also funded by the IL CURE FUND. This program officially ended on December 30, 2020, and final payments were issued to grantees in February of 2021 (FY 2021). No future funding rounds are planned for this program.

#### Housing Stability Services (HSS) for the Illinois Rental Payment Program

This program was funded by the U.S. Department of Treasury under the Consolidated Appropriations act of 2021. The Illinois Department of Commerce and Economic Opportunity (DCEO) applied to the U.S. Treasury on behalf of Illinois and was awarded funds. DCEO then sub-granted a portion of the IL ERA Award to IHDA in connection with the operation of the ILRPP and the HSS agency partners. HSS agencies were utilized to assist with administering the ILRPP by conducting outreach and intake for the rental assistance component. In FY 2022 to date, the Authority has continued funding disbursements under Round 1.0 of the program, with a combined \$2,769,179.88 disbursed. Future application funding rounds are anticipated for this program, following its administrative transfer to IHDA's Strategic Response Department (SRU), on February 1, 2022.

#### Cook County Mortgage Foreclosure Mediation Program

The program was first established in 2010 in response to the economic recession and related mortgage crisis which began in 2008. The program was designed to provide Cook County homeowners in foreclosure with critical support and to help them explore their options to either stay in their homes or negotiate a respectable exit as early as possible once the foreclosure process begins. IHDA manages the helpline and housing counseling agency components of the grant. This initial iteration of the program ceased activity in 2017 but was reopened in 2021 as a response to the risk of rising foreclosures due to the COVID-19 pandemic. In FY 2022 to date, the IHDA Board approved 5 agencies to enter into fee for service agreements with the Authority on July 16, 2022. Quarter 1 grantee reports were due on February 7, 2022. Program activity is expected to continue across the remainder of FY 2022 and into FY 2023, with the final termination date set for October 1, 2022 (FY 2023). Additional rounds are expected for this program.

#### **Housing Stability Counseling Program**

On September 28, 2021, NeighborWorks America announced a grant of \$2.7 million for IHDA to administer activity under HSCP. The program is intended to support the delivery of housing counseling services by HUD-approved housing counseling for those facing housing instability, such as eviction, default, foreclosure, loss of income, or homelessness. Funding is derived from the American Rescue Plan Act of 2021. IHDA launched a Request for Applications, for participating counseling agencies on July 19, 2021, for which it received 22 applications. 21 organizations were ultimately recommended for funding and approved by the IHDA Board on October 15, 2021. Grantees finalized their legal agreements with IHDA on January 31, 2022, and the program officially began on February 1, 2022. HSCP is expected to run for 1 year, with final activity planned to end on January 21, 2023 (FY 2023).

#### **Housing Counseling Resource Program**

HCRP is a new 3-year program, funded by the Federal Home Loan Bank of Chicago, which will provide \$1 million in annual grants to HUD approved housing counseling agencies across Illinois, to expand organizational capacity and services to better reach minority and low - and moderate - income homebuyers. The authorization to accept the funds was approved by the IHDA Board in December of 2021. A Request for Applications was released subsequently released by the Authority on January 12, 2022, with a submission due date on February 14, 2022. IHDA anticipates putting Round 1 grantee recommendations before the Board for consideration and approval on April 15, 2022. Round 1's term is planned to begin on June 3, 2022.

#### **Land Bank Capacity Program and Technical Assistance Network**

In FY 2022, the Authority will continue disbursing funds to grantees under Rounds 1 and 2 of the program, with Round 1 activity expected to end across July and August of 2022 (FY 2023). This is due to staggered grantee legal agreement termination dates. Round 2 program activity is expected to end on August 18, 2022 (FY 2023), following a 6-month program term extension which was presented to and approved by the IHDA Board on February 18, 2022. Additionally, following an application and recommendation process, the IHDA Board on February 18, 2022, approved an additional \$162,603.38 in combined funding to 3 existing LBCP Round 2 grantees. These additional funds were sourced from a reallocation of remaining National Foreclosure Settlement funding which were under IHDA's custody. Other FY 2022 LBCP activity includes the approval by the IHDA Board on July 16, 2021, of an additional \$215,665 in funding for the City of Peoria (an existing LBCP grantee), following the reallocation from the Office of the Illinois Attorney General of unused National Foreclosure Settlement funding which had previously been earmarked for the Peoria metro area.

#### **Strong Communities Program**

The Strong Communities Program (SCP) was established with \$30,000,000 of the total \$200,000,000 in funds appropriated from the Build Illinois Bond Fund to the Department of Revenue for the Illinois Housing Development Authority. SCP will provide grant funds to units of local government throughout the state to address local affordable housing needs and community revitalization efforts. The Program aims to return vacant residential properties to productive and taxable use through rehabilitation and it provides funds for demolition in cases where properties are beyond repair and negatively impacting neighboring residences. As a result, SCP will increase property values, create jobs, help reduce crime, generate additional tax revenue, and attract further community investment. In FY 2021, IHDA released the first application funding round for SCP, with awards in the amount of \$10 million. Application and financing activity for this program occurred entirely within calendar year 2020, specifically during FY 2021. As such it was outside of the reporting period for this report (FY 2020).

#### **Rental Housing Support Programs**

The Authority will continue to serve as the State's administrator for the RHS Program and expects to continue its grant compliance activities for both the RHS Program and the LTOS Program. Based on the level of real estate document recording fees collected in the State, the RHS Program is expected to receive approximately \$16,500,000 in FY 2022. The funding will be partially used to renew three-year contracts with LAAs set to expire during FY 2022. Additionally, the funding will be used for new grants for additional LTOS properties and to allow for the potential expansion of the Re-Entry program.

#### **National Housing Trust Fund**

The Authority will continue to serve as the State's designated administrator ("Participating Jurisdiction") of the federal NHTF program. The amount of NHTF funds allocated to the State FY2021 was \$30,702,615 and the Authority expects approximately \$15,000,000 in Fiscal Year 2022. In FY2022, the Authority will continue to fund Permanent Supportive Housing under the NHTF Program.

#### **Other Financing Requests**

'Other' financing requests represent a subordinate resource request. This funding depends on the availability of funds in various programs including, HOME, Trust Fund, Bond, FAF, State Tax Credits, and Federal Tax Credits.

#### **COVID-Related Emergency Funding**

Using federal Consolidated Appropriations Act of 2021, the Illinois Rental Payment Program (ILRPP) was launched in May 2021, to provide a lifeline for renters and landlords who continued to experience financial hardships related to the COVID-19 Pandemic. Supported by more than \$584 million in federal funding, ILRPP was one of the first statewide programs in the country to fully disburse 100 percent of available funds. This funding assisted 63,964 low-and extremely low-income Illinois renters to stay safe at home and avoid eviction during the pandemic. IHDA received 101,694 completed applications from both renters and landlords in all 102 counties throughout Illinois. Per program rules, payments could cover missed rent payments as far back as June 2020 and prepay rent through August 2021, or until the \$25,000 was exhausted, whichever came first.

Through the American Rescue Plan Act of 2021 (ARPA), a second iteration of the Illinois Rental Payment Program (ILRPP 2.0) is scheduled to launch in December 2021. With approximately \$300 million committed to this second round of funding, we expect to assist 35,000 households throughout the State of Illinois.

Using federal Consolidated Appropriations Act of 2021, the Illinois Department of Human Services (IDHS), in partnership with IHDA launched a Court-Based Rental Assistance Program (CBRAP) available to tenants and landlords across the State (except for Cook County). With the allocation of up to \$60 million for the CBRAP program, this program was designed to assist renters in eviction court. Renters must have experienced financial hardship, directly or indirectly, due to the pandemic and may qualify for a one-time grant matched to their specific need to cover up to 12 months of past due rent and 3 months of future rent to prevent eviction and homelessness.

Additionally, using ARPA funds, the Illinois Homeowner Mortgage Assistance Fund (ILHAF) is scheduled to launch in spring 2022. With 200 million committed, IHDA expects to assist 14,000 homeowners throughout the state and target 57 Illinois zip codes where the most vulnerable homeowners reside. Overall, the ILHAF program progress will be measured by the number of foreclosures prevented and the number of homeowners assisted in reducing their mortgage delinquency among the targeted populations. In addition, IHDA will contract with a network of housing counseling agencies and legal aid organizations to provide support to those individuals that need additional assistance or face language and technology barriers.

#### STRATEGIC PLANNING AND REPORTING

This report was prepared by the Strategic Planning and Reporting Department (SPAR). SPAR works to inform, bolster, and advise the Authority's planning and financing functions with transparent data and metrics, reliable reporting, and critical in-depth analysis. SPAR was initially formed in 2012 to address a growing need for improving its data research and related applications to assist in more efficiently operating its programs. In 2016, SPAR merged with other internal departments and teams, merging many important disciplines in the affordable housing world – housing high need populations, consolidated and comprehensive planning, legislative and financial analysis, market analysis and analytics, technical assistance, navigation of federal regulations, data purification and database development and administration - under one roof. SPAR's broad spectrum of expertise is used to provide IHDA and its partners with thorough information and thoughtful analysis. SPAR works in concert with virtually all of IHDA's departments providing the documentation, research and legwork needed to bring valuable affordable housing resources to Illinois and to plan across departments and agencies to adequately use those resources.
