Senator Mulroe offered the following Senate Resolution, which was referred to the Committee on Assignments:

#### SENATE RESOLUTION NO. 936

WHEREAS, Childhood cancer is on the rise; it is a global problem; every two minutes a child is diagnosed with cancer; that equals 300,000 children around the world every year; childhood cancer and adult cancers are not the same, yet treatment options for children continue to rely on downsized adult cancer protocols, many times with devastating effects; there are 16 major types of childhood cancers and over 100 different subtypes; the lack of childhood cancer research and cures has a tremendous impact on children and places a significant cost on society; this will continue until there is a monumental increase in funding for research and cures; and

WHEREAS, Pediatric cancer remains the leading cause of death by disease in children and young adolescents; the incidence of invasive cancer in children is up 29% in the past 20 years; even as the five-year survival rate continues to improve, the incidence of childhood cancer has been steadily increasing over the last few decades; in 80% of children with cancer, the cancer has already spread to other areas of the body by the time it is diagnosed; this is why children need treatment immediately; and

WHEREAS, Despite the need for childhood cancer awareness, financial support has not reached the same national level as other cancer awareness campaigns, many of which are for adults cancers; the Fiscal Year Consolidated Appropriations Act included over five billion dollars for the National Cancer Institute which is an increase of more than 174 million dollars over the fiscal year of 2016; of that over five billion dollars, only approximately 3.8% of that is allocated to childhood cancer research; nationally, childhood cancer is 20 times more prevalent than pediatric aids yet pediatric aids receives four times the funding that childhood cancer receives; and

WHEREAS, Numerous childhood cancer foundations and facilities work on treatments, but since most organizations work independently, no singular umbrella of awareness exists to unite or elevate awareness or provide a call to action that childhood cancer desperately needs and children deserve; and

WHEREAS, In the last 20 years, only three cancer medications have been specifically developed for children; in 25 years, the FDA has initially approved only two drugs for any childhood cancer; half of all chemotherapies used for childhood cancers are over 25 years old; the average age for a child with cancer is eight years old causing a child to lose 69 years of expected life; approximately 20% of all children with cancer will die from their disease, a secondary cancer, or complications from the treatment within five years of the diagnosis; more than 400,000 children will undergo treatment for cancer each year; every day, 43 children are diagnosed with cancer; due to treatments during childhood, by the time the child reaches their 30s to 40s more than 95% of childhood cancer survivors will have chronic health problems, and 80% will have severe or life threatening conditions; and

WHEREAS, More than 35 states have declared the month of September as Childhood Cancer Awareness Month; in 2016, President Obama proclaimed September as National Childhood Cancer Month; and

WHEREAS, As parents and advocates for children, our calling is to protect children, so we are compelled to greatly increase the awareness of childhood cancer and its devastation to children and their family; through this very awareness we can raise the greatly needed funding for research and new cures

that are better gauged for children; these children need and deserve a voice to help them reach a greater survival rate and, hopefully someday, a complete cure; and

WHEREAS, Childhood cancer has an international symbol, the Gold Ribbon, and a motto, "Go Gold"; these help increase not only awareness, but the support of the public who need to know how desperately these children need their help; support will also help the child's family not feel alone during this very desperate time; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare September of 2017 as Childhood Cancer Awareness Month in the State of Illinois in honor and memory of all the children that were taken too soon by cancer and in recognition of those children currently fighting the toughest battle of their lives.

Senator Hastings offered the following Senate Resolution, which was referred to the Committee on Assignments:

#### SENATE RESOLUTION NO. 950

WHEREAS, The United States Congress has let the Children's Health Insurance Program (CHIP) expire; this is the first time in two decades that this was allowed to happen; and

WHEREAS, CHIP is a federal health insurance option for working families without access to insurance; now, insurance for more than 100,000 Illinois children remains uncertain; and

WHEREAS, CHIP provides prenatal care to over 370,000 pregnant women across the nation; and

WHEREAS, Last year, Illinois received more than \$200 million to fund CHIP; that money will not run out until next year; and

WHEREAS, CHIP has helped decrease the number of uninsured children to a record low of 7%; and

WHEREAS, Children are our State's greatest asset; they must grow up healthy to support our future economy; and

WHEREAS, A five-year renewal plan is already drafted; Congress is expected to call it for a vote in the coming weeks; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the United States Congress to renew the Children's Health Insurance Program (CHIP) to provide stability and certainty to the children of Illinois; and be it further

RESOLVED, That suitable copies of this resolution be delivered to President Donald Trump, U.S. Senate Majority Leader Mitch McConnell, U.S. Senate Minority Leader Chuck Schumer, U.S. Speaker of the House Paul Ryan, U.S. House of Representatives Minority Leader Nancy Pelosi, and all members of the Illinois Congressional Delegation.

Senator Hutchinson offered the following Senate Resolution, which was referred to the Committee on Assignments:

#### SENATE RESOLUTION NO. 986

WHEREAS, The American Red Cross says that every two seconds someone in the United States needs blood; and

WHEREAS, Recent natural disasters, like Hurricanes Harvey and Irma, and human-caused tragedies, such as the mass shooting in Las Vegas, highlight the importance of blood donations to help save lives; and

WHEREAS, While an estimated 45.4 percent of men (54 million) in the United States are eligible to donate blood, only 8.7 percent of eligible men actually do; and

WHEREAS, Since 1983, the United States Food and Drug Administration (FDA), an agency under the United States Department of Health and Human Services (HHS), has prohibited the donation of blood by any man who has had sex with another man (MSM) at any time since 1977; and

WHEREAS, In December 2015, based on recommendations from the HHS Advisory Committee on Blood and Tissue Safety and Availability, the FDA promulgated revised regulations to allow an MSM to donate blood only if he had not been sexually active for the past 12 months; and

WHEREAS, Despite these recent steps toward a policy change, a double standard still exists under the policy as revised because it still treats gay and bisexual men differently from heterosexual men; and

WHEREAS, Illinois law prohibits discrimination against individuals on the basis of actual or perceived sex, sexual orientation, and gender identity; and

WHEREAS, A 12-month deferral policy for gay and bisexual men to donate blood is overly stringent given the scientific evidence, advanced testing methods, and the safety and quality control measure in place within the different FDA-qualified blood donation centers; and

WHEREAS, The American Public Health Association (APHA) has stated that no specific scientific rationale exists to justify a 12-month deferral policy; and

WHEREAS, Furthermore, the APHA's Executive Director wrote: "Instead of protecting and enhancing the nation's blood supply, a 12-month deferral represents a missed opportunity to save the lives of people in need of blood"; and

WHEREAS, The Williams Institute of the University of California at Los Angeles School of Law estimates that, based on the population of eligible and likely donors among the MSM community, lifting the federal lifetime deferral policy on blood donation by an MSM would result in 4.2 million newly eligible male donors, of which 360,600 would likely donate, generating 615,300 additional pints of blood; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the President of the United States and the Secretary of the United States Department of Health and Human Services to adopt policies to repeal the current discriminatory donor suitability policies of the United States Food and Drug Administration (FDA) regarding blood donations by men who have had sex with another man and, instead, direct the FDA to develop science-based policies, such as criteria based on behavior and not a donor's sexual orientation; and be it further

RESOLVED, That suitable copies of this resolution be delivered to the President and Vice President of the United States, to the Secretary of the United States Department of Health and Human Services, to the Speaker of the United States House of Representatives, to the Majority Leader of the United States Senate, and to each United States Senator and Representative from Illinois in the Congress of the United States.
