WHEREAS, Monmouth is the burial place of The Great Nicola, his magician father and brother, and his pet elephant, Nizie, used in one of Nicola's most famous stage illusions; and

WHEREAS, Monmouth is developing a professionally curated museum, celebrating and interpreting the rich history of Western Illinois and the innovators, such as The Great Nicola; and

**SENATE JOINT RESOLUTION
CONSTITUTIONAL AMENDMENT NO. 20**

SC0020

RESOLVED, BY THE SENATE OF THE ONE HUNDRETH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that there shall be submitted to the electors of the State for adoption or rejection at the general election next occurring at least 6 months after the adoption of this resolution a proposition to add Section 2.5 to Article IV and amend Section 2 of Article V of the Illinois Constitution as follows:

ARTICLE IV
THE LEGISLATURE

SECTION 2.5. TERM LIMITS

A person may not be elected to the office of State Senator for more than three terms or the office of State Representative for more than five terms. Service before the second Wednesday in January of 2019 shall not be considered in the calculation of a person's service.

ARTICLE V
THE EXECUTIVE

SECTION 2. TERMS

These elected officers of the Executive Branch shall hold office for four years beginning on the second Monday of January after their election and, except in the case of the Lieutenant Governor, until their successors are qualified. They shall be elected at the general election in 1978 and every four years thereafter. A person may not be elected to more than two terms for each Executive Branch office. Service before the second Monday in January of 2019 shall not be considered in the calculation of a person's service.
