WHEREAS, According to new research from the United Nations, growing antimicrobial resistance linked to the discharge of drugs and some chemicals into the environment is one of the most worrying health threats today; and

WHEREAS, Studies have linked the misuse of antibiotics in humans and agriculture over the last several decades to increasing resistance, but the role of the environment and pollution has received little attention; and

WHEREAS, Clear evidence shows that antimicrobial compounds from households, hospitals, pharmaceutical facilities, and agricultural run-off released into the environment, combined with direct contact between natural bacterial communities and discharged resistant bacteria, is driving bacterial evolution and the emergence of more resistant strains; and

WHEREAS, Evidence shows that multi-drug resistant bacteria are prevalent in marine waters and sediments close to aquaculture, industrial, and municipal discharges; and

WHEREAS, Careless disposal of antibiotics could produce "ferocious superbugs" United Nations environment experts warn that have resistance to current antibiotics; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the U.S. Congress to review existing federal laws for the disposal of unused antibiotics and to pass new laws to prevent the creation of "superbugs" and to fund research into the treatment of, and creation of, new drugs to fight antibiotic resistant "superbugs"; and be it further

RESOLVED, That suitable copies of this resolution be delivered to President Donald Trump, U.S. Senate Majority Leader Mitch McConnell, U.S. Senate Minority Leader Chuck Schumer, U.S. Speaker of the House Paul Ryan, U.S. House of Representatives Minority Leader Nancy Pelosi, and all members of the Illinois Congressional Delegation.

WHEREAS, The proposed highway has come to be known as the Southwest Illinois Connector; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that the Southwest Illinois Connector Task Force is created in order to study the following:

(1) the cost, feasibility, and environmental impact of the connector;

(2) the short and long term economic impact to the region; and

(3) all options for funding the connector both public and private; and be it further

RESOLVED, That the Southwest Illinois Connector Task Force shall consist of the following members:

(1) one member appointed by the Minority Leader of the Senate, who shall serve as Chair;

(2) one member appointed by the President of the Senate;

(3) one member appointed by the Speaker of the House;

(4) one member appointed by the Minority Leader of the House;

(5) the Secretary of Transportation, or his or her designee;

(6) a representative of Randolph County appointed by the Chairman of the Randolph County Board of Commissioners;

(7) a representative of Perry County appointed by the Chairman of the Perry County Board of Commissioners;

(8) a representative of Jackson County appointed by the Chairman of the Jackson County Board;

(9) a representative of Monroe County appointed by the Chairman of the Monroe County Board of Commissioners;

(10) a representative of the Illinois Farm Bureau appointed by its President;

(11) a representative of Southern Illinois University Carbondale appointed by its Chancellor;

(12) a representative of the International Union of Operating Engineers Local 150 appointed by its President;

(13) a representative of the Kaskaskia Regional Port District appointed by its Chairman;

(14) a representative of the Illinois Municipal League appointed by its President; and

(15) a representative of the Illinois Realtors Association appointed by its President; and be it further

RESOLVED, That members of the Southwest Illinois Connector Task Force shall serve with no compensation; the Illinois Department of Transportation shall make all Department information available to the Task Force and provide expertise as needed and available; and be it further

RESOLVED, That the Southwest Illinois Connector Task Force shall meet a minimum of four times and make recommendations to the General Assembly and the Illinois Department of Transportation before December 31, 2018.
