Senator Rose offered the following Senate Resolution, which was referred to the Committee on Assignments:

#### **SENATE RESOLUTION NO. 1534**

WHEREAS, The State of Illinois has become a major center for energy production and storage in the United States; and

WHEREAS, Illinois stores the second highest amount of natural gas in the United States; and

WHEREAS, The Department of Natural Resources regulates gas operations in the State; and

WHEREAS, The safety of Illinois residents is a priority for the Department of Natural Resources when developing new regulations; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that the Department of Natural Resources shall compile a report reviewing the current regulations for gas pipelines in Illinois and make recommendations for changes of those regulations to improve public safety; and be it further

RESOLVED, That the report shall include a review of the regulations applicable to gas extraction, as well as underground gas storage; and be it further

RESOLVED, That this report shall be sent to the Senate President and Senate Minority Leader, the Speaker of the House and House Minority Leader, and the Office of the Governor, no later than December 31, 2018.

Senator Bush offered the following Senate Resolution, which was referred to the Committee on Assignments:

#### SENATE RESOLUTION NO. 1561

WHEREAS, For the last quarter-century, the Ford Motor Company has garnered a reputation for mishandling complaints of sexual and racial harassment at their production plants across the nation, giving rise to a string of lawsuits in the 1990s, an Equal Employment Opportunity Commission (EEOC) investigation, and a \$22 million settlement to Ford employees who experienced harassment; and

WHEREAS, The allegations made by female employees have included crude comments about women's bodies, graphic images of male genitalia, groping, males simulating sexual acts or masturbating in front of the women, and supervisors who offered favorable treatment to women who would have sex with them; and

WHEREAS, The culture at the Ford plants enabled this conduct, thereby causing many of the women who reported harassment to be mocked, dismissed, threatened, or ostracized; and

WHEREAS, While Ford touted its purported commitment to cracking down on this hostile work environment of the 1990s, it continued to delay firing those accused of harassment, did not provide adequate sexual harassment training, and failed to stamp out retaliation against those women who reported misconduct, leaving workers to conclude that offenders would go unpunished; and

WHEREAS, Ford has done little to address the longstanding culture of sexual harassment at its plants, resulting in another EEOC investigation, a recent \$10 million settlement of sexual harassment claims, and continuing litigation between Ford and employees who suffer from this pervasive sexual and racial harassment; and

WHEREAS, Ford's Chicago Assembly Plant and the Chicago Stamping Plant, which together employ over 5,700 people, of which just under a third are women, have been the source of half of all sexual harassment and gender discrimination complaints lodged against Ford with the EEOC; and

WHEREAS, Although United Auto Workers (UAW) is the union entrusted with representing Ford workers in employment matters, UAW not only breached its duty of fair representation to women experiencing harassment at Ford's Chicago plants, but many of the alleged perpetrators of harassment included UAW representatives and leadership; and

WHEREAS, Harassment victims who sought protection from UAW were instead rebuked for tattling on a union brother and putting a man's job at risk, and bullied into tolerating the harassment as just another aspect of the job; and

WHEREAS, Neither Ford nor UAW took any action to mitigate the inherent conflict of interest that arises when both a victim and the perpetrator of sexual harassment are members of the same collective bargaining unit and the union must fairly represent both workers; and

WHEREAS, Many of the known and unknown women who became victims of sexual harassment throughout their employment with Ford are Illinois workers who have suffered serious psychological and physical trauma, economic loss, and retaliation including loss of their jobs as a result of Ford and UAW's gross mishandling and failure to eradicate this impermissible behavior; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the Equal Employment Opportunity Commission, the Illinois Department of Human Rights, and the Illinois Department of Labor to investigate the culture of harassment at Ford's Illinois plants, and provide increased support for the brave women who have come forward to make their voices heard; and be it further

RESOLVED, That we call upon the Governor of Illinois to review all state contracts with Ford Motor Company for compliance with the Illinois Human Rights Act, the Illinois Procurement Code, and other laws and regulations governing state contractors; and be it further

RESOLVED, That we call upon the National Labor Relations Board, the Equal Employment Opportunity Commission, the Illinois Department of Human Rights, and the Illinois Department of Labor to investigate UAW's role in facilitating the harassment at Ford's Illinois plants, including whether it breached its duty of fair representation to union members who were victims of harassment; and be it further

RESOLVED, That suitable copies of this resolution be delivered to Governor Bruce Rauner, the Acting Chair and the Commissioners of the Equal Employment Opportunity Commission, the members of the National Labor Relations Board, the Director of the Illinois Department of Human Rights, the Director of the Illinois Department of Labor, the United Automobile Workers International Executive Board, and the Board of Directors at Ford Motor Company.

Senator Lightford offered the following Senate Joint Resolution, which was referred to the Committee on Assignments:

#### SENATE JOINT RESOLUTION NO. 60

WHEREAS, The State of Illinois recognizes the need for the cleanliness of Illinois waterways for public safety, public recreation, economic benefit, and historical character, whether a large or small body of water, whether rural, urban, or suburban in location; and

WHEREAS, The third Saturday of September is established globally as "International Coastal Cleanup Day", coordinated by the Ocean Conservancy and promoted by various like-minded Illinois partner organizations; and

WHEREAS, The coalition of Illinois Global Scholar stakeholders acts for the benefit of Illinois students and works to promote Public Act 099-0780; it partners with organizations to ensure the protection, restoration, and health of Illinois waterways; and

WHEREAS, Service learning promotes effective student growth opportunities; a statewide coordinated day of action facilitates active citizen engagement, and offers a particular opportunity for active student engagement in effective environmental improvement through trash collection, data collection, and data analysis; and

WHEREAS, To coordinate with the International Coastal Cleanup Day effort, partner organizations and schools across Illinois will facilitate the opportunity for Illinois student participant groups to partner with other student participant groups in different countries, providing Illinois students with the opportunity to communicate and collaborate globally, discussing and sharing their efforts and findings; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that we declare September 9-15, 2018 as "Illinois Waterway Cleanup Week" in the State of Illinois.

Senator Connelly offered the following Senate Joint Resolution, which was ordered printed and referred to the Committee on Assignments:

# SENATE JOINT RESOLUTION CONSTITUTIONAL AMENDMENT NO. 27

SC0027

RESOLVED, BY THE SENATE OF THE ONE HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that there shall be submitted to the electors of the State for adoption or rejection at the general election next occurring at least 6 months after the adoption of this resolution a proposition to add Article XV to the Illinois Constitution as follows:

# ARTICLE XV ETHICS

# SECTION 1. DEPARTMENT OF GOVERNMENTAL ETHICS

- (a) A Department of Governmental Ethics is created. The Department of Governmental Ethics shall have jurisdiction over the Executive and Legislative Branches of the State government, together with all units of local government, school districts, public colleges, and public universities. The Department shall be led by the Director of Governmental Ethics and shall be under the authority of the Governmental Ethics Commission. The General Assembly shall provide by law for the operation of the Department.
- (b) The Department of Governmental Ethics shall have a State Government Division, which shall have the authority to investigate, prosecute, and ensure compliance with laws relating to the duties and responsibilities of the agencies and other bodies, elected and appointed officers, and employees of the Executive and Legislative Branches of the State government, including, but not limited to: the preservation of, and the public's access to, information about, created by, or held by those agencies and other bodies, officers, and employees; transparency and accountability in finance and contracting by those agencies and other bodies; ethical standards applicable to those agencies and other bodies, officers, and employees; prohibitions on conflicts of interest applicable to those officers and employees; and prohibitions on employment by former officers and employees.
- (c) The Department of Governmental Ethics shall have a Local Government Division, which shall have the authority to investigate, prosecute, and ensure compliance with laws relating to the duties and responsibilities of units of local government and the elected and appointed officers and employees of units of local government, including, but not limited to: the preservation of, and the public's access to, information about, created by, or held by those units of local government, including their governing bodies of public hearings and other meetings held by units of local government, including their governing bodies and any committees or other subdivisions thereof; transparency and accountability in finance and contracting by units of local government; ethical standards applicable to those officers and employees; prohibitions on conflicts of interest applicable to those officers and employees; and prohibitions on employment by former officers and employees.
- (d) The Department of Governmental Ethics shall have an Education Division, which shall have the authority to investigate, prosecute, and ensure compliance with laws relating to the duties and responsibilities of school districts, public colleges, and public universities and the elected and appointed officers and employees of school districts, public colleges, and public universities, including, but not limited to: the preservation of, and the public's access to, information about, created by, or held by those school districts, public colleges, and public universities of public hearings and other meetings held by school districts, public colleges, and public universities, including their governing bodies and any committees or other subdivisions thereof; transparency and accountability in finance and contracting by school districts, public colleges, and public universities; ethical standards applicable to those officers and employees; prohibitions on conflicts of interest applicable to those officers and employees; and prohibitions on employment by former officers and employees.

#### SECTION 2. GOVERNMENTAL ETHICS COMMISSION

A Governmental Ethics Commission is created. The Commission shall have authority over the Department of Governmental Ethics, shall receive reports from audits of the Department conducted by the

Auditor General, shall approve the budget of the Department, and shall appoint the Director of the Department and such other officers as it may determine. The General Assembly shall by law provide for the operation of the Commission and shall determine the size, manner of selection, and compensation of the Commission. The commission shall not be composed of a majority of members from any one political party.

#### **SCHEDULE**

This Constitutional Amendment takes effect upon being declared adopted in accordance with Section 7 of the Illinois Constitutional Amendment Act.
