His awards include the Silver Star, the Navy and Marine Corps Medal, three Bronze Stars Medal of Valor {sic} (Bronze Star Medals with Valor), a Bronze Star Medal, a Purple Heart Medal, the Defense Meritorious Service Medal, two Joint Service Commendation Medals with Valor, two Navy and Marine Corps Commendation Medals, and the Joint Service Achievement Medal, with three Navy and Marine Corps Achievement Medals. Senior Chief Officer Owens was a SEAL and I just highly recognize an amazing gentleman. On January 29th, Senior Chief Owens died from wounds sustained while in combat supporting oversea contingency operations. He's survived by his wife and three children and his father. Madam President, while I have the -- while I have the floor, I'm going to request that we withdraw this right now and I'll come back to it.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Let -- the record will reflect your request, Senator. With leave of the Body, we will return to Senate Bill 1351. Senator Biss. On the Order of Senate Bill 1351, the gentleman indicates he wishes to proceed. Please read the bill.

SECRETARY ANDERSON:

I move that Senate Bill 1351 do pass, notwithstanding the veto of the Governor.

Signed by Senator Biss.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Senator Biss.

SENATOR BISS:

Thank you very much, Madam President, Members of the Senate. We debated this bill at length back in the spring. This is the Student Loan Bill of Rights that deals specifically with the conduct of student loan servicers, a small collection of private companies involved in the student — in the servicing of student loans. This is one of several bills moving across the country to place some regulations on those servicers to ensure that they don't direct student loan borrowers to unduly expensive options, to make sure that they're providing students with all the information they need to make choices they need. As we know, there's an

extraordinary crisis of student loan debt in this State and in this country and one piece of that crisis is what I would characterize as predatory activity on the part of some student loan servicers. This bill would address that problem and I would appreciate Aye votes for this motion.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Is there any discussion? Senator Althoff, for what purpose do you rise?

SENATOR ALTHOFF:

Thank you, Madam President. Will the sponsor yield? PRESIDING OFFICER: (SENATOR LIGHTFORD)

Sponsor indicates he will yield. Senator Althoff.

SENATOR ALTHOFF:

Thank you. Senator Biss, I really admire the idea and concept behind this piece of legislation. I mean, we really do want to address the burdening debt that most of our students are facing as they graduate and -- and move on to a job. I know that this bill specifically states that we want the service providers to direct the loanees to the appropriate program, but in -- in no way, this legislation, allows us to control the interest of that loan, the -- the length of time. It -- it doesn't address the actual loan itself. It just basically says that these service providers have to lay out all options and basically say that there are several options and this one might be good for this particular student.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Senator Biss.

SENATOR BISS:

Yeah, I think that's a fair characterization. This bill will not solve every problem related to student loan debt. I wish it

would. But it will take an important step in the right direction. PRESIDING OFFICER: (SENATOR LIGHTFORD)

Senator Althoff.

SENATOR ALTHOFF:

And the only other question I have, Senator Biss, is, it's my understanding that these service providers actually receive a monetary incentive based on whichever program that they do direct the student toward and the programs that obviously are the most effective for the student receive a lower reimbursement amount, so to speak, an incentive amount. Is that true?

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Senator Biss.

SENATOR BISS:

Well, the economics is pretty complicated. It depends on the specific case and the specific example. But I would add that one of the findings that has led to, for example, an important lawsuit in this field is not just about whatever monetary incentives may exist, but also about the fact that if the servicer has churned through cases as quickly as possible, they're decreasing their own overhead, which increases their profit irrespective of those incentives, and that's part of the challenge that this bill is seeking to address.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Senator Althoff.

SENATOR ALTHOFF:

To the bill. I think everybody in this Chamber wants to ensure that we are doing the best possible job on behalf of our residents who have these horrific student loans that they're having difficulty paying back. I mean, I know I have family members who

finished medical school and are still paying back the loans that they incurred during that process. However, I really believe that this piece of legislation doesn't address the largest complaint that most of these individuals have with this type of loan, which is the ability to restructure the loan. All this does is require twenty service providers to ensure that they provide as much information to the student as they possibly can about which program is better for them. My contention is we would be better served if we educated those individuals and let them know what all of these programs provide. So I'm not going to say which way you should vote, but I really think you need to look at this very seriously and consider how it's going to be interpreted by your constituents. I believe most will think that we somehow are correcting the debt problem and I really don't know if this legislation goes that far. So thank you, Senator Biss.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Further discussion? Senator Nybo.

SENATOR NYBO:

Thank you, Madam President. Will the sponsor yield for two questions?

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Sponsor indicates he'll yield for two questions.

SENATOR NYBO:

Senator, you and I had a long back-and-forth about this bill when it was originally in this Chamber several months ago. But - but, again, can -- can you summarize for us what is the problem that you are trying to address or fix with this bill?

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Senator Biss.

SENATOR BISS:

The problem is the problem of student loan servicers failing to take the time needed to lay out all the options for student loan borrowers who are seeking other ways of making their repayments and, therefore, not enabling them to choose what is often the best option for them - quite frequently, for instance, income-based repayment.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Senator Nybo.

SENATOR NYBO:

To the bill, Madam President.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

To the bill minus the second question.

SENATOR NYBO:

Yeah, minus the second question and here's why. I mean, there's a lot of discussion in the Chamber and -- and I'm just gonna kind of go right to the heart of this one and I want people to -- to -- to hopefully pay attention to what I'm about -- about to say. This is a complicated issue, no doubt, Senator, and -- and I appreciate what you're trying to do. Here's the problem that I see: The problem that we're -- that we're dealing with is -- is excessive and sometimes what some would say is unreasonable levels of student debt. And -- and there's a problem that you're trying to tackle. I analogize this to a situation where you've got a bad car or a broken car - okay? - and -- and instead of going to the manufacturer who -- who made the car or instead of going to the dealership who sold you the car, you're going to the gas station with this bill, the person who puts gas in your car and has nothing to do with the underlying problem with the vehicle.

And -- and what I would say to your bill is, there's no doubt that there's a student loan problem, but let's really deal with it. Servicers are just servicing the loan. They're not setting the terms. They're -- they're not setting the rates. They're not making the loans. They're not financing the loans. If there's a problem that you're trying to address here with student loans, let's really address it. But going after the servicers, the gas stations, that's not going to fix the problem. So I urge a No vote because we're really not focusing in on the problem with student loans and all we're touching upon is -- is an ancillary service that's provided in connection with student loans. We're not really addressing the problem with this bill. I urge a No vote.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Further discussion? Further discussion? Seeing none, Senator Biss, to close.

SENATOR BISS:

Thank you, Madam President. I appreciate the discussion. I just want everyone in the Chamber, if there's anyone who's unsure of how they're going to vote, to analyze the -- the thoughtful and -- and reasonable comments that were made by the two speakers. Neither one of them said they didn't support anything in the bill. Neither one of them said there was anything wrong with the bill. I don't think either one of them even said that the bill wouldn't help solve a problem that I laid out that is a real problem. What they said is, the bill doesn't fix the entire student debt crisis facing our State. Guilty as charged. Guilty as charged. But the bill takes a real step. The bill takes on a real problem. The bill will actually make life better for real student loan borrowers

in every single one of our districts. So please vote Yes. PRESIDING OFFICER: (SENATOR LIGHTFORD)

The question is, shall Senate Bill 1351 pass, notwithstanding the veto of the Governor. All those in favor will vote Aye. Opposed, Nay. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Take the record. On that question, there are 37 voting Yea, 19 voting Nay, 0 voting Present. Senate Bill 1351, having received the required three-fifths majority, is declared passed, notwithstanding the veto of the Governor. Senator Biss, on Senate Bill 1720. Out of the record. Ladies and Gentlemen, please turn your attention to the top of page 5 on your Calendars, Motions in Writing, Override Specific Recommendations of Senate Bills. Senate Bill 1462. Senator Holmes. The lady indicates she wishes to proceed. Please read the bill.

SECRETARY ANDERSON:

I move that Senate Bill 1462 do pass, notwithstanding the specific recommendations of the Governor.

Signed by Senator Holmes.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Senator Holmes.

SENATOR HOLMES:

Thank you so much, Madam President. I would like to see us go ahead and just pass the underlying bill that we had originally, which did pass in this Chamber with a vote of 52 to 3. This was establishing an Entrepreneur Learner Permit program. And basically what it was doing is it was limiting it to certain industries, those specifically dealing with newer services such as information services, biotechnology, and green technology

businesses. And it is a pilot program, which will be revaluated in two years to see if the effectiveness of it works. I would appreciate an Aye vote in overriding this amendatory veto.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Thank you, Senator. Is there any discussion? Senator Righter, for what purpose do you rise?

SENATOR RIGHTER:

Will the sponsor yield, please, Madam President?
PRESIDING OFFICER: (SENATOR LIGHTFORD)

Sponsor indicates she will yield, Senator. Senator Righter. SENATOR RIGHTER:

Thank you very much, Madam President. Senator Holmes, as long as I've been around here, I usually get most of the reasons why Members file motions to override vetoes. This one I do not get, because as I understand it, the Governor took your idea, which was to establish this Learner's -- Entrepreneurs {sic} (Entrepreneur) Learner's Permit program for a few industries, and said, that's a good idea, let's do it for everybody. And -- now maybe I've got that wrong, but that's my understanding of the amendatory veto. Why are you objecting to that?

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Senator Holmes.

SENATOR HOLMES:

Yes. And the reason I am doing -- I -- I think it's -- it's a great idea. The reason I wanted it limited to these is because I think, after a two-and-a-half-year budget impasse, it's fiscally irresponsible to go further. So why not set this up as a pilot program and see how well it works? If it ends up not working well as a pilot program, we haven't invested anymore into

it, but we've certainly laid the groundwork to see if this program is viable moving on.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Senator Righter.

SENATOR RIGHTER:

Senator Holmes, what was the -- what was the projected cost of the underlying bill?

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Senator Holmes.

SENATOR HOLMES:

I wish I knew. We have been going after that number since this bill came. As a matter of fact, right before the veto came up, I also went to research it and we were informed that the Department had a ballpark figure that they would prefer not to share.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Senator Righter.

SENATOR RIGHTER:

Well, putting aside for a moment the concern -- the newfound concern about fiscal matters, I mean, if you don't know how much the bill is going to cost, how do you know it would be too expensive to allow all industries to take advantage of it?

SENATOR HOLMES:

We had a cap...

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Senator Holmes.

SENATOR HOLMES:

Yes. We had a cap on this of five hundred, which the Governor chose in this veto to remove - and that is irresponsible. And,

I'm sorry, I think on this side we have demonstrated some fiscal responsibility in the last budget we passed. So I'm a little offended by that. We can just keep discussing this bill and not have your editorialized version of the past budget we passed.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Senator Righter.

SENATOR RIGHTER:

First of all, Senator, as long as Madam -- the Madam President allows, I will editorialize on anything I want. The point is this, is that the Governor said, you know what, let's not have Springfield pick the people who could take advantage of a program; let's let the market decide who should be -- who should be into this program. If there's a group over here that wants to take advantage of it, because that's a burgeoning industry, let's let them do it, or a group over here as opposed to the group in the middle. Now I apologize, Senator, if I offended you. Let's get - you're right - let's get back to the issue. I do apologize for that. Let's get back to the issue. You just said it's a really good idea to open it up to all industries, so why don't we just open it up to all industries?

PRESIDING OFFICER: (SENATOR LIGHTFORD)

For the sake of all bills, we would like to stay within the confinement of the legislation that we are discussing. President rule. Senator Holmes.

SENATOR HOLMES:

Thank you, Madam President. And certainly let's do that if this pilot program proves that it's viable in these burgeoning new industries. It's not that I'm opposed to expanding this at some point. As a matter of fact, if you are such a proponent of doing

that, I certainly look forward to seeing you introduce some legislation in the spring and I'll be happy to work on that and be a cosponsor with you to expand this to other businesses and industries.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Senator -- Senator Righter.

SENATOR RIGHTER:

To the lady's motion, please, if I might, Madam President.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

To the motion, Senator.

SENATOR RIGHTER:

Thank you. Senator, I will do that. But I hope we don't have to spend that paperwork, because if we defeat your motion, then perhaps there's a chance you'll reconsider, we'll file a motion to accept the Governor's veto, and allow the market to decide which industries are growing and which ones are not. I urge a No vote. Thank you, Madam President.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Thank you, Senator. Is there any further discussion? Seeing none, Senator Holmes, to close.

SENATOR HOLMES:

Yes, I would prefer an Aye vote again on this bill, which we all passed, fifty-two votes, in spring Session. It is a good idea and I do like the fiscal responsibility at this point of limiting it when we are having budget difficulties. I would appreciate an Aye vote.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

The question is, shall Senate Bill 1462 pass, notwithstanding the specific recommendations of the Governor. All those in favor

will vote Aye. Opposed, Nay. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Take the record. On that question, there are 49 voting Yea, 7 voting Nay, 1 voting Present. Senate Bill 1462, having received the required three-fifths constitutional majority, is declared passed, notwithstanding the specific recommendations of the Governor. Please turn your Calendars to page 2. We will be going to the Order of Senate Bills 3rd Reading on the top of page 2. Senator Link, on Senate Bill 2-2-5. Senator Link seeks leave of the Body to return Senate Bill 225 to the Order of 2nd Reading. Leave is granted. On the Order of 2nd Reading is Senate Bill 225. Mr. Secretary, are there any Floor amendments approved for consideration?

SECRETARY ANDERSON:

Floor Amendment No. 2, offered by Senator Link.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Senator Link, on Amendment No. 2.

SENATOR LINK:

Thank you, Madam President. The amendment becomes the -- the bill. I would ask -- I'll explain it on 3rd Reading and ask for its adoption.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Thank you, Senator. Is there any discussion? Seeing none, all those in favor will say Aye. Opposed, Nay. The Ayes have it, and the amendment is adopted. Are there any further Floor amendments approved for consideration?

SECRETARY ANDERSON:

No further amendments reported.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

3rd Reading. Now on the Order of 3rd Reading is Senate Bill 225. Mr. Secretary, please read the bill.

SECRETARY ANDERSON:

Senate Bill 225.

(Secretary reads title of bill)

3rd Reading of the bill.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Senator Link.

SENATOR LINK:

Thank you, Madam President. This bill amends the Township and Municipal Code to allow a person previously convicted of a felony to hold office under certain specific -- conditions. Under this bill, a person previously convicted may run for office if he or she: one, completed his or her sentence; two, completed the sentence fifteen years or more years prior to running for office and has not been convicted of a crime during that fifteen years; three, filing an affidavit of proper election authority stating the person is in compliance. I want to explain a case that's --I -- I just have a hard time hearing myself, Madam President. I want to explain a case that's familiar in my area of a man that was convicted of a crime thirty-six years ago. And I'll tell you the crime - he stole an air conditioner as a kid, was convicted of a felony. He went on to change his life and became a pillar of the community in which he serves. He has worked with children. He has worked in his church. He got elected to school board years ago. Then he turned around after that and was elected a township trustee. And then when we passed a law a couple years ago, he couldn't run for trustee anymore and ran for school board again and was the top vote-getter in the community. Then a sore loser

filed a case to the State's Attorney stating that this person is ineligible to be on the school board. Now, I want to explain, I'm a Democrat, my State's Attorney's a Republican. He brought this to attention to me also. He not only -- the State's Attorney not only signed in as a proponent of this bill in a witness slip today, he also has sent a letter to the Governor and the Pardon Board in favor of this gentleman having a pardon. But as Senator Trotter indicated in committee, some of this stuff takes forever to get done as a -- far as a pardon goes. So with this bill, what it does, is we're not -- we're making him still serve {sic} an extra fifteen years after his sentence before he could run for office, but we're letting the voters of the -- of the district, whatever they're running for, be the decision-makers on this person because he'd have to file a paper stating what had happened in your life. I think it's time that we do everything in criminal justice in this Body to entice -- tighten things up, but we also look at giving people a second chance. This is a second chance that the voters have an opportunity. This is not being soft on crime by no stretch of the imagination. And I don't care if you're looking for a flyer against me, I welcome it, because I'll tell you right now, this is the right thing to do for the right people and I would ask for an affirmative vote.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Is there any discussion? Senator Nybo, for what purpose do you rise?

SENATOR NYBO:

To the bill, Madam President.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

To the bill, Senator.

SENATOR NYBO:

Well, I am certainly not going to be the Member to send out a nasty flyer about you, Senator Link. So, let me say -- and we've had a conversation about this bill and it's hard to criticize you for thinking that this is a good idea. And if the Body were to come to that conclusion, it'd be -- it'd be hard to criticize that. It's just this is something that I personally am not comfortable with and so, as you know, I'm going to be a No vote on this bill. And so I'd -- I'd advise and caution Members on our side to pay attention to what we're voting for at this point and -- and vote how you wish. But I will be a No vote.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Further discussion? Senator McCann, for what purpose do you rise?

SENATOR McCANN:

Thank you, Madam President. To the bill.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

To the bill, Senator.

SENATOR McCANN:

I would like to thank the sponsor, first and foremost, for bringing the bill, for bringing this amendment. I thank the sponsor for allowing me to join him as his chief cosponsor. I think here, serving in the General Assembly for a little over six years as I have, I see every day where we have the opportunity — opportunity knocks at our door every day, and it knocks and it knocks and it knocks and it says, here's an opportunity to do something good. And some days we seize that opportunity and some days we don't. Here's an opportunity to do a great thing. Here's an opportunity to — to return the voice of the people to the

people. When we talk about limited government - we as Republicans, we like to talk about limited government and local control - there are instances around this State where the voters go to the ballot box, they fully know about these convictions. They -- it's a part of the program. It's a part of the election process. It's a part of the campaign. Flyers are mailed out on these candidates and the electorate goes to the voting booth and chooses these candidates in spite of it. And interestingly enough - here -here now, if you don't listen to anything else I have to say today, listen to this - we don't have the same set of rules for ourselves. You can get out of prison -- you can be convicted, serve your time, and that same day you get out, you're released, you can run for Governor, you can run for State Senator, and you can run for State Rep. But we're telling people in their communities - remember, we're the -- we're the limited government folks over here - we're telling people in their communities that we know better than they These people know. I -- Reagan is my favorite President and he said he didn't fear the people, his belief was in the people. He believed that the people would deliver us. I agree with that wholeheartedly. I believe that whether you're a Democrat or a Republican, a liberal or a conservative, this is the right thing to do. Opportunity is knocking here once again. It's -it's time to restore the voice to the people and to also make it clear that we do not believe that every sentence is a life sentence. If we don't believe that, here's another opportunity to put those words into motion. Thank you, Madam President.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Thank you, Senators. Further discussion? Senator Hastings, for what purpose do you rise?

SENATOR HASTINGS:

To the bill, Madam President.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

To the bill, Senator.

SENATOR HASTINGS:

I want to tell a story about an eighteen-year-old young man who made a horrible mistake and committed a crime of mail fraud. The judge had sentenced him to community service hours and to pay restitution for what he had done. He did all that. decided that he wanted to become a public servant. He wanted to be a firefighter to help save people's lives. He went through the ranks. He went from the bottom, just a regular old probie, all the way up to a fire chief of a major municipality, where they respond to fires on countless occasions. He saved lives. served his time. And as the Chairman of the Criminal Law Committee over the last year, this Chamber has overwhelmingly voted for juvenile expungement to give our youth second chances that have committed non-violent offenses. This Chamber has also voted in overwhelming majority to seal felony records after a certain period of time. So this isn't that far off from the actions that we've already taken. In my situation, the eighteen-year-old man ran for mayor of a municipality after he had served as a fire chief and has served our community so proudly. He won by an overwhelming majority. But because of something that happened when he was eighteen years of age, has plaqued him past his sentence, when all's he wants to do is serve his community. We've all made mistakes at a young age and we can all understand that we've all grown from our mistakes and become better people. And that's why I think this bill is just fine for people who want to serve our

community and give them a second chance, as long as they're fully rehabilitated. And to the sponsor of this bill, this bill is not an easy bill, but you're a courageous person, and you, like me, you can send all the negative mail you want, but I know this, when I look at myself in the mirror, I'm going to know that my towns are led by people who actually care and that have grown from their mistakes and they want to do the right thing. Thank you, Madam President. I ask for an Aye vote.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Senator Link, to close.

SENATOR LINK:

Thank you, Madam President. I want to thank the two previous speakers. And I think this exemplifies what we're talking about here of a second chance. But, Senator McCann, I thank you for bringing up something I forgot about, that everybody in this building could run without this law. We should be looking at this how the voters think. And I think the voters in my -- in the community that not only elected this gentleman to the school board as the top vote-getter, but they done it twice. They elected him top vote-getter as a trustee. You know, let's give the hands of the voters back to the voters to make these decisions, not making 'em here. We're opening the door for a second chance for people and I think it's about time to do the right thing. I ask for an affirmative vote. Thank you.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

As the bill has an immediate effective date, the passage of this measure will require a three-fifths majority. The question is, shall Senate Bill 225 pass. All those in favor will vote Aye. Opposed, Nay. The voting is open. Have all voted who wish? Have

all voted who wish? Have all voted who wish? Take the record. On that question, there are 40 voting Yea, 17 voting Nay, 0 voting Present. Senate Bill 225, having received the required constitutional majority, is declared passed. Senator Bush, on Senate Bill 403. Senator Bush. The lady indicates she wishes to proceed. Please read the bill. Senator Bush seeks leave of the Body to return Senate Bill 403 to the Order of 2nd Reading. Leave is granted. On the Order of 2nd Reading is Senate Bill 403. Mr. Secretary, are there any Floor amendments approved for consideration?

SECRETARY ANDERSON:

Floor Amendment No. 1, offered by Senator Bush.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Senator Bush, on Floor Amendment No. 1.

SENATOR BUSH:

I would ask that we adopt Floor Amendment No. 1 and I will explain it on 3rd.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Thank you, Senator. Is there any discussion? Any discussion? Seeing none, all those in favor will say Aye. Opposed, Nay. The Ayes have it, and the amendment is adopted. Are there any further Floor amendments approved for consideration?

ACTING SECRETARY KAISER:

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Senator Bush, on Floor Amendment No. 3, please.

SENATOR BUSH:

Thank you, Madam President. I would ask that we adopt Floor Amendment No. 3 and I will explain it on 3rd.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

3rd Reading. Now on the Order of 3rd Reading is Senate Bill 403. Mr. Secretary, please read the lady's bill.

ACTING SECRETARY KAISER:

Senate Bill 403.

(Secretary reads title of bill)

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Senator Bush.

SENATOR BUSH:

Thank you, Madam President. Members, Senate Bill 403 allows a natural disaster income credit of up to seven hundred fifty dollars for 2017 in the counties where a major disaster was declared in July. The claimant must be an owner of the property or business and must have reported the damage properly to the appropriate authority in conjunction with IEMA or FEMA, or applied for disaster relief from FEMA. Most of you know that Lake County, along with four other counties - McHenry, Cook, Kane - were declared natural disaster areas by the Governor of the State of Illinois. We experienced unprecedented flooding. Thing was interesting about this flooding - it was very different than what we've seen in the past - it was really a product of about eight

inches of rain that fell over a very, very short amount of time and caused pockets of flooding, where literally people's homes that had never flooded before were -- the -- the water was up to the stop signs in -- in their neighborhoods and a neighborhood immediately next to that had absolutely no damage. These were not houses along rivers. This was not -- you know, these weren't homes This is really a product of a that were in floodplains. unbelievable rain that fell from our skies. And as we all know, when a hurricane happens, we're insured for that; when a tornado comes through, we're insured for that. But when a flood happens, we're not used to these kinds of floods. When they happen along a floodway, those people already have insurance and are required by, frankly, those that hold their mortgages to have them. this happened in areas where they didn't have those protections in place. These counties -- you need about eighteen million dollars in damage to -- in order to be in a position to get help from the federal government. We reached about twelve million dollars in damage. Roughly thirty-two hundred homes were damaged, of which about two hundred forty of -- two hundred forty-four of those were considered to be major damage, where more than fifty percent of the property was damaged and will need to be repaired. really trying to -- I realize that this is not everyone's community. We're talking about seven counties. This also includes Cook, Carroll, Henry, Jo Daviess, Lee, Ogle, and Rock Island, Stephenson, and Whiteside counties, as they had incredible flooding damage. Perhaps we need to look at something on a statewide level going forward. Maybe we can look at this as a pilot program. But I'm asking for a Yes vote. There are many residents in Lake County that live in homes that value under a

hundred thousand dollars and they need help taking down the -- the -- the drywall that has mold on it and those kinds of things. Those are the people we're really trying to reach. I'm happy to answer any questions. I would urge an Aye vote. And I truly ask you to look outside of your own district and understand this is something devastating to our State and certainly devastating to those -- those of us who represent these areas.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Thank you. Is there any discussion? Senator Althoff, for what purpose do you rise?

SENATOR ALTHOFF:

Will the sponsor yield?

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Sponsor indicates she will. Senator Althoff.

SENATOR ALTHOFF:

Senator Bush, you know I am a strong supporter of this legislation. In fact, you were kind enough to allow me to be one of your chief cosponsors. A couple of questions, however, for clarity. During natural disasters, the State of Illinois allows assessors to reduce property assessments based on the damage done. In the event I were a property owner and I obtained that reduction in assessment, can I still apply for this tax credit?

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Senator Bush.

SENATOR BUSH:

I'm sorry, I do not believe you can. No.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Senator Althoff.

SENATOR ALTHOFF:

Thank you very much, Madam President. I -- I know for sure you cannot, so be very clear. Number two, you indicated that it had to be an owner-occupied home basically. My understanding is, the legislation actually says it must be your primary residence. So for those of us who live in that area, who this is a second vacation home, can I use this tax credit?

SENATOR BUSH:

No, you may not.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Senator Bush.

SENATOR BUSH:

I'm sorry, Madam President. Gosh, I jumped the -- jumped the shark I think. No, you may not.

SENATOR ALTHOFF:

And that is the point that I'm trying to make. This -- this tax credit that we would hopefully pass and graciously offer these homeowners really is limited in scope as to who can apply and who would receive that type of tax credit. So I would hope that the State of Illinois would not lose a huge amount of money on this, but would recognize that these are homeowners that will again improve the property and raise that property tax value so that the local entities are really achieving a benefit to this type of a tax credit. And also, in this area, as -- as you know, Senator Bush, many of these property owners cannot obtain flood insurance, so they really are at, you know, the -- they're at the discretion of weather and sometimes weather is not always kind to us. So I, too, for my colleagues over on this side of the aisle, I would urge an Aye vote. Thank you very much for carrying the bill.

Senator Hutchinson, for what purpose do you rise? SENATOR HUTCHINSON:

Thank you -- thank you, Madam President. To the bill.

I just wanted to speak very quickly in support of Senator Bush's bill. Largely, I'm really keyed into when you're narrowing the base and how difficult it is for local governments to do that. But this is one of those situations where we all know people who've had something like this hit and they're underinsured and the cost and the emotional -- you know, the draining that happens as a result of this is really significant. So it's a onetime thing and I really wanted to say I appreciate all of the narrowing that you did to make sure this got to people who needed it the most. So with that, I urge the support of the Body with an Aye vote on this bill. Thank you.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Further discussion? Senator Oberweis, for what purpose do you rise?

SENATOR OBERWEIS:

A question of the sponsor.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Sponsor indicates she will yield. Senator Oberweis.

SENATOR OBERWEIS:

Senator, as a lifetime resident of Kane County, this -- and also representing most of Kane County, this certainly sounds like a wonderful idea. But then I started to think about this. Do you have an idea of how much this is going to cost the taxpayers of

Illinois? And, secondly, where that money is going to come from? PRESIDING OFFICER: (SENATOR LIGHTFORD)

Senator Bush.

SENATOR BUSH:

So we certainly worked with Revenue on this bill and -- and addressed all the concerns they had. And I can tell you, I stayed up the night before last really thinking about this bill and the fiscal impact, because that's important to us obviously. We know how difficult these last few years have been. But I believe that the money will come from the additional dollars that we're already receiving because of the amount of insurance work that has been done. So, remember, we put people to work because of this flood. Been a tremendous amount of dollars coming into our coffers because of the additional work, all the materials that have been bought, the sales tax from those materials and, in addition, I think we'll see those too. So I think those will be offsetting, if not completely offsetting. That's number one. Number two, we've seen some fiscal impact -- I did ask for a fiscal impact and we believe the numbers were going to be somewhere between one million and three million. I was given a number that comes about -- to about 1.9 million - just received that information earlier today. I don't know how they compiled it, frankly. I'm not saying it's not accurate, but I think we're somewhere between one and two million dollars.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Senator Oberweis.

SENATOR OBERWEIS:

To the bill, Madam President.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

SENATOR OBERWEIS:

Ladies and Gentlemen of the Senate, while this would obviously help my home county, I have to say that the idea that we're going to raise as much through additional sales taxes as the result of a disaster, as the cost of repairing things from the disaster, is — is just not quite sensible to me. I also believe that taxpayers in Illinois have suffered enough. We don't have an extra million here and a million there for good ideas. If we had lots of money, I could support this. But with the financial condition the State of Illinois is in, I have to strongly urge a No vote, even though it would benefit my home county.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Senator Link, for what purpose do you rise?

SENATOR LINK:

Thank you, Madam President. To the bill. As a strong supporter of this, I just want to remind the previous speaker, if they watched on TV and you saw businesses that have been businesses for years, will be probably not reopening because of this, what - what this flood happened to 'em. But if they do reopen, it's going to cost them extreme amount of money. So I'm telling you, we're not paying their bill by giving 'em a seven-hundred-and-fifty-dollar tax break. We're trying to do a little token to say the State actually is concerned on what happened to you. This was unforeseen. This was the twelfth hundred-year flood we had up there. And the municipalities have done everything to try to avoid this in the future -- or in the past, that it wouldn't happen in the future by buying homes that are in floodplains, by demolishing those homes. They have worked on their levees. They have done

everything possible to avoid the circumstances that happened in this last summer. So I got to say, would -- somebody who has a heart and feels really sorry for what happened to those individuals, if we can't afford a million or three million dollars to help those people in disaster, then we're in the wrong business what we're doing here today. I would ask for a strong affirmative vote. Thank you.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Is there any further discussion? Senator Rezin, for what purpose do you rise?

SENATOR REZIN:

Thank you, Madam President. Question for the sponsor.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Sponsor indicates she will yield. Senator Rezin.

SENATOR REZIN:

Thank you. I do apologize, I don't know a whole lot about this bill other than I was listening to the discussion as well. We all have major floods in our districts. So, four or five years ago, I had a major flood in 2013 that caused about a hundred and fifty million dollars' worth of damage in my district. As a result, we've been studying flood mitigation and what we can do to alleviate all of the damage that -- that causes it. So I read on your bill that this only encompasses certain counties. Well, flooding, as we know, is a problem everywhere. We have five-hundred-year floods every other year. So my comment or my question would be, if you're going to do this for your particular area, is -- is this something that you will look at and add an amendment to, to include all of our counties that may deal with this catastrophic flooding and try to deal with how to -- how -- how to

deal with the constituents who do not have flood insurance and are trying to just simply rebuild their homes?

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Senator Bush.

SENATOR BUSH:

Thank you so much for that question. And I share your concerns. So we don't specifically name counties, but we do give this a time frame for when the flooding occurred. So, let's be honest, it does really just include these counties. I think those are conversations we should have. You said you had -- had a hundred and fifty million, so you did qualify for FEMA. We did not. So there are no programs in these counties. But having said that, I've -- I've talked to several Members who that is certainly their concern, is what happens in other parts of the State when we experience flooding? I think it's something we should be talking about. I don't know if it's an amendment to this bill, but it's certainly things I'm -- willing to consider conversation, you know, and we can talk about it as the bill goes over to the House. But I think those are conversations for another bill. And I would be happy to work with you on that. And I -- I mean that sincerely, because when this happens in your area, I mean - you obviously know - this is devastating. These are people that are - many of them - have -- don't have the resources. And I would disagree with my colleague from Kane County that -- I do believe that there will -- there is quite a bit of revenue that we are generating in the repairs that are being made to those homes. And certainly not -- not believing that's going to pay for it, but I just wanted to make the point that there is that reinvestment and the values of those properties are important, too, to the tax rolls. But -- so

- and I know I'm being really long-winded on this and everybody probably wants to head out of here soon - but I so respect the work that you've done in your county. I know you did a lot on floods -- flooding last year, worked this last legislative Session working on storm management in your area. Lake County's done a, I believe, a tremendous job - I can certainly address that - in stormwater management, but we always have more work to do. But I would pledge to you to work on something statewide. But I don't know for this bill, these taxpayers, you know, we're coming up on tax time, so we need something passed now if we expect to be able to help them. And I don't -- so I can't really commit to changing this bill, but I absolutely commit to working on something that we can do statewide.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Senator Rezin.

SENATOR REZIN:

Thank...(microphone cutoff)... To the bill.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

To the bill, Senator.

SENATOR REZIN:

I appreciate your leadership regarding this bill. Despite having a hundred and fifty million dollars' worth of damage, that did not rise to the level of qualifying for, you know, the FEMA grants as well. There's a certain level - I believe it's about seventeen or twenty-one million dollars - of uninsured property before you rise to that level. So despite having all of this catastrophic damage, we did not, in a very rural, low-income part of my district, qualify for FEMA as well. Again, I understand where you're coming from, trying to help your citizens. We all

try to do that when we have these catastrophes and -- and disasters that go through our district. Again, my point is, instead of looking at one particular area and putting a specific date in this legislation to make sure it's for a particular area, you know, I would -- much prefer working on a comprehensive bill for the entire State that affects all of our districts so we have the same protections that you're offering your constituents as well. And I look forward to working with the sponsor on that. Thank you. PRESIDING OFFICER: (SENATOR LIGHTFORD)

Further discussion? Seeing none, Senator Bush, to close. SENATOR BUSH:

Thank you for that little signal, Madam President. I just ask that you all consider how you would vote today if this catastrophe happened in your district. And we had a tremendous amount - nearly eight million of our damage was uninsured. So I would just ask for an Aye vote and I do promise to continue to work and will continue to work to make the bill -- whatever we need to do before it goes through the House. But I urge an Aye vote and I would thank you very much ahead of time.

I want to begin by thanking the Illinois Emergency Management Agency, the Department of Military Affairs, and the Comptroller's Office for really working with us to draft this specific bill and tweak some of the technical language. The amendment actually - the bill - gives funding flexibility for only the Illinois National Guard when another state or territory makes a request for and accepts mutual aid assistance from the Illinois National Guard through the Emergency Management Assistance Compact. The proposed change allows the Governor, who already has this authority for State-proclaimed emergencies, to identify, the Comptroller to direct,

This actually came to be -- want to point to my wonderful chief cosponsor, Iris Martinez, who actually benefitted from our Illinois Emergency Management Agency, as well as the State Department, for returning her safely to us after she was vacationing in Puerto Rico. So I would ask for an Aye vote. PRESIDING OFFICER: (SENATOR LIGHTFORD)
