He took that gunboat past tremendous fortifications and other gunboats in the dead of night, took it to the Union Navy, and made off with a huge boat as well as many guns that the Union Army used. He became a captain. Keep in mind he was illiterate. He became a captain because he knew all the -- the rivers and the streams in and around Charleston. He assisted the Union Army and the Union Navy in taking those areas when Sherman showed up. He assisted in the siege and the capture of Wilmington, which was a crucial battle of the Civil War. He became a high officer in the Army, including an Admiral in the -- the Navy. He became a sixterm Congressman from South Carolina, raised a family, was the last African American to sit on a state commission in 1895, when the Ku Klux Klan and the Red Shirts, through a campaign of terror and murder, eliminated the African American voting base. Robert Smalls is truly an American hero, a hero of the Civil War, an intrepid sailor, and one of the most brilliant officers of the Civil War. And I just want to bring the attention of the Illinois Senate, during this month, to Robert Smalls, and the book is Be Free or Die: Escape from Slavery Union Hero {sic} (Be Free or Die: The Amazing Story of Robert Smalls' Escape from Slavery to Union Hero).
