PRESIDING OFFICER: (SENATOR HARMON)

Thank you, Senator. Senator Aquino moves for the adoption of

Floor Amendment No. 1 to Senate Bill 426. All in favor, say Aye. Opposed, Nay. The Ayes have it, and the amendments have {sic} been adopted. Have there been any further Floor amendments approved for consideration?

SECRETARY ANDERSON:

No further amendments reported.

PRESIDING OFFICER: (SENATOR HARMON)

3rd Reading. Senate Bill 5-5-8. Senator Sims, would you like to call your first bill? Mr. Secretary, please read the bill. SECRETARY ANDERSON:

Senate Bill 558.

(Secretary reads title of bill)

3rd Reading of the bill.

PRESIDING OFFICER: (SENATOR HARMON)

Senator Sims, on your first bill.

SENATOR SIMS:

Thank -- thank you, Mr. President, for pointing out several times that this is my first bill on the Senate Floor. Senate Bill 5-5-8, as amended, provides for the grounds and the procedures to obtain an ex parte protective order. Last year, we passed a bill that consolidated several of the orders and this would -- this is a trailer bill to clean that up. So I'd answer any questions. Ask for its adoption.

PRESIDING OFFICER: (SENATOR HARMON)

Thank you, Senator. Is there any discussion of Senator Sims' first bill in the Senate? Is there any discussion? Senator Koehler, thank you. Senator Koehler, for what purpose do you rise? SENATOR KOEHLER:

Thank you, Mr. President. Question of the sponsor.

PRESIDING OFFICER: (SENATOR HARMON)

Sponsor indicates that he will yield. Senator Koehler.

SENATOR KOEHLER:

Well, first of all, I think that the Senate ought to enact a rule that no one may have their first bills, at least on the Democratic side, without Senator Haine being here. You know, we're -- we're kind of at a disadvantage today because we rely on his wit and wisdom to -- to do this. But, Senator, could you just explain this bill? I mean, there's a lot of terms in here which are Latin in nature. And why can't we have just plain English in some of our -- of our bills?

PRESIDING OFFICER: (SENATOR HARMON)

Senator Sims.

SENATOR SIMS:

Lot of the -- the terms that are in here and -- and that are in -- that are Latin are -- they are from the common law, so they are readily understood and they're pretty -- pretty -- pretty basic terms.

PRESIDING OFFICER: (SENATOR HARMON)

Senator Koehler.

SENATOR KOEHLER:

But don't we pass legislation for all the people of Illinois? And -- and isn't it somehow understood that if -- if the common people don't understand what we're doing in legislation, that there's somehow a risk? I mean, they may be vulnerable and they don't even know it.

PRESIDING OFFICER: (SENATOR HARMON)

Senator Sims.

SENATOR SIMS:

That's why we have outstanding Senators like you, Senator Koehler, so you can go back to your district and have those town hall meetings and explain it to them, so that we -- they know the good work that we're doing here in the State Capitol for them.

PRESIDING OFFICER: (SENATOR HARMON)

Senator Koehler.

SENATOR KOEHLER:

Thank you. I appreciate that, but I may not be that smart. I mean, you know, I've got to have some help on this thing. I -- I just think that we ought to use plain language. But, in truth, I'm just so glad that Senator Sims is -- is my seatmate here. I wish he would wear some bow ties a little more often, but I welcome him to the Illinois Senate.

PRESIDING OFFICER: (SENATOR HARMON)

Thank you, Senator Koehler. Is there any further discussion? Senator Raoul, for what purpose do you rise?

SENATOR RAOUL:

A question of the sponsor.

PRESIDING OFFICER: (SENATOR HARMON)

The sponsor indicates that he will yield. Senator Raoul.

SENATOR RAOUL:

Senator Sims, I was reading the analysis and it's -- the amendment says that it deletes all and becomes the bill. I -- I'm curious as to what was deleted? What was the original bill that was deleted?

PRESIDING OFFICER: (SENATOR HARMON)

Senator Sims.

SENATOR SIMS:

Originally, Senator, it was a shell bill. We -- we -- and we

took the original contents of the bill out and put in the -- the -- the contents that are before you.

PRESIDING OFFICER: (SENATOR HARMON)

Senator Raoul.

SENATOR RAOUL:

Mr. President, can you direct Senator Sims to at least bend down a little bit? I don't know whether he's been fully de-chipped or whether his mic was -- been reduced from across the Rotunda, but I did not here his response to the essential question that I think the Members of this Body needs -- need -- need to hear. Perhaps, can you caution Senator Sims that we have a different decorum here? We actually listen to debate in the Senate.

PRESIDING OFFICER: (SENATOR HARMON)

Thank you, Senator Raoul. In case you didn't hear Senator Raoul, Senator Sims, in the Senate we do listen to debate and the microphones are not on at all times. So it -- it's when the Presiding Officer repeats your name, the microphone goes live. I'm afraid Senator Raoul may not have heard your last answer, so I will recognize you now to repeat it. Senator Sims. SENATOR SIMS:

Thank you, Mr. President. Duly noted that decorum is -- is -- is different in the Senate than it is -- than it is in the House. Again, it's -- to -- to answer Senator Raoul's question, this was a vehicle bill the first time. The amendment stripped the contents of the vehicle bill out and put in the contents that are before you.

PRESIDING OFFICER: (SENATOR HARMON)

Senator Raoul.

SENATOR RAOUL:

So I'm -- I'm looking at the language of the initial vehicle bill and it says it was the Bill of Rights for Children. Am I to assume that you, by deleting the Bill of Rights for Children, you don't think that children should have rights anymore in the State of Illinois?

PRESIDING OFFICER: (SENATOR HARMON)

Senator Sims.

SENATOR SIMS:

That's absolutely not the case, Senator. As we have so many outstanding young people who are in the gallery today watching us, I want them to have the same rights that -- that every other citizen across the State of Illinois has.

PRESIDING OFFICER: (SENATOR HARMON)

Senator Raoul.

SENATOR RAOUL:

Can you enumerate what those rights are as they are in the bill that you've now amended? Because we started out with a Bill of Rights for Children. So I want to know what your bill does exactly to give children in the State of Illinois those rights.

PRESIDING OFFICER: (SENATOR HARMON)

Senator Sims.

SENATOR SIMS:

If a child needs an ex parte or -- or a domestic violence -- domestic order of protection, they can get them under this bill.

PRESIDING OFFICER: (SENATOR HARMON)

Senator Raoul.

SENATOR RAOUL:

Is -- is that the only right? You know, 'cause I -- we started out with a Bill of Rights and, you know, there was supposed

to be -- I assume, by the title of the bill, there was supposed to be a number of rights that the children of the State of the Illinois should be protected by and I -- I assume that with your bill that you were going to try -- try to make that effort to do so. Or is it your intention to have the bill amended in the House to list the Bill of Rights for Children, because you still think you're operating in the House of Representatives instead of the Senate? PRESIDING OFFICER: (SENATOR HARMON)

Senator Sims.

SENATOR SIMS:

No, Senator, I'm -- I'm very -- very sure of where I am right now. The -- the bill before you deals with the subject matter at hand, which is the creation and the -- the -- the cleanup of the violence -- violence order of protections. I'm -- but I'm certainly willing to work with you if you want to make sure we have a new piece of legislation that addresses the children's bill of -- rights. I'm willing to work with you on that.

PRESIDING OFFICER: (SENATOR HARMON)

Senator Raoul.

SENATOR RAOUL:

...the -- to the bill.

PRESIDING OFFICER: (SENATOR HARMON)

To the bill, Senator.

SENATOR RAOUL:

Mr. President, we have a lot of time left to work. I -- I - I -- I -- I -- I don't know whether Senator Sims knows we can get deadlines extended to work on what the original objective of this bill was as introduced, to work on the Bill of Rights of Children. I think the underlying issue of his amendment is an important

matter and we should advance it. But I -- I just don't believe that this is the work of a -- of a fine upstanding Senator, to -- to -- to -- to ignore the Bill of Rights for Children. I'm a little disappointed, because I've worked historically across the Rotunda with then Representative Sims and -- and now he's suggesting -- he started out by saying this was a trailer bill. Now he's just suggesting a trailer bill to the trailer bill. I -- I -- I suggest that Senator Sims take this bill out of the record and work on it to make sure we stand up for the Bill of Rights of Children here in the State of Illinois.

PRESIDING OFFICER: (SENATOR HARMON)

Thank you, Senator Raoul. Is there any further discussion? Senator Hutchinson, for what purpose do you rise? SENATOR HUTCHINSON:

Question of the sponsor.

PRESIDING OFFICER: (SENATOR HARMON)

Sponsor indicates that he will yield. Senator Hutchinson. SENATOR HUTCHINSON:

I'm concerned. I am -- I -- I listened to the exchange with the previous speaker and I -- I just am concerned. So I would -- I would like to know exactly how long did you work on this bill? PRESIDING OFFICER: (SENATOR HARMON)

Senator Sims.

SENATOR SIMS:

Senator, we've -- we've worked on this bill -- soon after we passed the cleanup language -- or passed the original bill. Later -- late last year, the -- the Attorney General's Office came to us, and the Cook County State's Attorney came to us, seeking the cleanup language that you have before you. And we've been -- been

working on with that -- working with them since that point to get where we are here today. We still have -- we still have some -- we still have a little way to go, I'll be honest. We have a few cleanup matters that we will take care of, technical in nature, that we will take care of in the House. But we've been working on this for quite some time.

PRESIDING OFFICER: (SENATOR HARMON)

Senator Hutchinson.

SENATOR HUTCHINSON:

So, you're telling me, you spent next to no time on this? You know, as -- as we debate very substantive matters in the Senate, as you know, we tend to spend a lot of time on issues and I'm -- and I'm really just wondering whether or not you are -- you have the ability to actually dive deep into a conversation about whether or not we should protect children and negotiate it to a point where we can actually pass something like this. Because at the end of the day, as a mother of three children, I don't know how I could possibly support something that guts the Bill of Rights for Children. Like -- and -- and that you spent absolutely no time on and I -- I haven't heard a response that would ease my -- my comfort as it relates to that, because, you know, it's always all about the children.

PRESIDING OFFICER: (SENATOR HARMON)

Senator Sims.

SENATOR SIMS:

Thank -- thank you, Senator. Let me assure you and allay your fears that we are not gutting the Bill of Rights for Children. That is not the bill you have before you. The bill you have before you deals with an -- an issue for the -- obtaining domestic

violence orders of protection. I am -- I, too, am a father of two young -- two beautiful young daughters, who would not -- who would not look favorably upon me gutting the Bill of Rights -- Bill of Rights for Children, so that's not what this bill does. And I -- I don't know if I've ever had -- had my abilities questioned in this Chamber or the other, back from my days as a staff person, so -- but I have -- I -- I know we have a -- a bill before us that will improve the quality of life for the people of the State of Illinois.

PRESIDING OFFICER: (SENATOR HARMON)

Senator Hutchinson.

SENATOR HUTCHINSON:

Well, I know that what we have before us is not a bill that guts the rights of -- Bill of Rights for Children, 'cause you gutted it in the gut-and-replace in the bill itself. I mean, that happened when you picked up the bill itself. That's why I'm really wondering whether or not the technical aspects of this are really up to snuff. And so I just -- at this moment in time, I -- you know, I'm getting to know working with you as a colleague and, you know, in some respects, you're doing pretty good, but I really think this falls short. I really think at this point in the game, you know, we're -- we got a couple of weeks left to go at the end of the thing, and due to the fact that you can't seem to acknowledge the fact that you absolutely just gut and replaced something that was incredibly important to us, I -- I would have to concur with the previous speaker. I think you should pull this out of the record. I think -- I really -- I -- unless you can give me some -- some reason that would assure me that you can actually get this task done.

PRESIDING OFFICER: (SENATOR HARMON)

Senator Sims.

SENATOR SIMS:

Again, this -- this is a -- this is a bill that will make sure that we have -- there are -- that we have -- we have public safety across the State. We talked earlier this year, particularly about lethal violence orders of protection and things -- and things of the like. We specifically talked about how we were -- how we'd be able to create a process that will make it easier for people to be protected, and that's what this bill does. But we will -- I -- I'm -- and I -- I will make the same offer to you that I made to -- I made to one of the previous speakers. I'll work with you on making sure that we strengthen the Bill of Rights for Children. We want to make sure that they have all the rights that they are entitled to. And I'm willing to work with you every day to make that happen.

PRESIDING OFFICER: (SENATOR HARMON)

Senator Hutchinson.

SENATOR HUTCHINSON:

To the bill.

PRESIDING OFFICER: (SENATOR HARMON)

The bill, Senator.

SENATOR HUTCHINSON:

I -- I would urge -- I mean, this is a -- a brand-new colleague. It's his first piece of legislation and I know, you know, he wears nice suits, looks good, has a nice smile, tends to kind of put people at ease and everything, but what you just heard, right now, was the biggest example of spin you can have. And the fact that he's able to do that so cleanly is something we should

all be looking sideways at. So I, personally, would urge everyone in this Chamber No -- No votes. Thank you.

PRESIDING OFFICER: (SENATOR HARMON)

Thank you, Senator. Is there further discussion? Senator Jones, for what purpose do you rise?

SENATOR JONES:

To the bill, Mr. President.

PRESIDING OFFICER: (SENATOR HARMON)

To the bill, Senator.

SENATOR JONES:

You know, Senator Sims, you should have did the work on the bill before you brought it to the Floor. Telling your two other colleagues that, you know, we can work together. We work on bills before we bring it to the Floor. That's how we do it in the Senate. I urge a No vote. Simply, one, Senator Sims has -- came from the House. Any bill that -- Representative Sims sent over here, we always killed. So I would urge everyone to vote No. I want to see a sea of red on the board. Thank you, Mr. President. PRESIDING OFFICER: (SENATOR HARMON)

Thank you, Senator. Is there further discussion? Senator Rose, do you wish to get in on the action? SENATOR ROSE:

So, welcome, Senator Sims. One of the things that I -- took me a long time to -- to learn over here - and I think Senator Link will tell you I still haven't learned it - is that they don't like former House Members in the Senate very much. And so, I've heard you talking quite a bit here, Senator Sims, about speakers have said this and speakers have said that. What has Speaker Madigan said about this bill?

Is there further discussion? Senator Holmes, for what purpose do you rise?

SENATOR HOLMES:

Thank you so much, Mr. President. I just have one quick question, 'cause I got a little confused here. Senator Raoul said that this is a vehicle on a vehicle. No, that this was a trailer on a trailer bill. So, my question is, does that make it a double-wide trailer?

PRESIDING OFFICER: (SENATOR HARMON)

Senator Sims.

SENATOR SIMS:

No, Senator. I've -- I've got a -- I got that bill coming up later -- later on this Session.

PRESIDING OFFICER: (SENATOR HARMON)

Is there further discussion? Senator Morrison, for what purpose do you rise?

SENATOR MORRISON:

I'd like to ask the -- the new Senator a question, please, about his bill.

PRESIDING OFFICER: (SENATOR HARMON)

Sponsor indicates that he will yield for a question. Senator Morrison.

SENATOR MORRISON:

Senator Sims, I know these first bills are hard. I remember mine and our colleagues can be sort of nasty. I just had a couple easy questions. So this is a vehicle bill, correct?

SENATOR SIMS:

The original bill was a vehicle bill. Yes, ma'am.

PRESIDING OFFICER: (SENATOR HARMON)

Senator Morrison.

SENATOR MORRISON:

I have yet to hear anything about a vehicle - an automobile, truck, van. I mean, did I miss that part of your discussion entirely or is it still coming?

PRESIDING OFFICER: (SENATOR HARMON)

Senator Sims.

SENATOR SIMS:

No -- no, ma'am. The -- vehicle bill, it's -- it's a term of art, talking about the type of bill that the bill -- the -- the underlying bill was.

PRESIDING OFFICER: (SENATOR HARMON)

Senator Morrison.

SENATOR MORRISON:

Thank you. And my final question is, this deals with domestic violence?

PRESIDING OFFICER: (SENATOR HARMON)

Senator Sims.

SENATOR SIMS:

Yes.

PRESIDING OFFICER: (SENATOR HARMON)

Senator Morrison.

SENATOR MORRISON:

...how would your bill impact international violence?

PRESIDING OFFICER: (SENATOR HARMON)

Senator Sims.

That's a -- that's a bill that's outside -- it's outside of the purview of this legislation.

PRESIDING OFFICER: (SENATOR HARMON)

Senator Morrison.

SENATOR MORRISON:

...saying -- so you're saying international violence is okay?
We're only going to worry about domestic?

PRESIDING OFFICER: (SENATOR HARMON)

Senator Sims.

SENATOR SIMS:

Absolutely -- absolutely not. We will -- we'll deal -- we're dealing with this issue at this time. But we can -- we'll deal -- we'll deal with international violence and I'm -- I'm work -- I'll work with you and we have been -- we've traveled internationally together on a trade mission with some of our other colleagues and we worked on some of those issues and we'll continue to do so.

PRESIDING OFFICER: (SENATOR HARMON)

Senator Morrison.

SENATOR MORRISON:

Well, thank you, Senator Sims, and I hope with more time in the Senate you will be able to have better legislation.

PRESIDING OFFICER: (SENATOR HARMON)

Is there further discussion? Senator Van Pelt, for what purpose do you rise?

SENATOR VAN PELT:

I have a question of the sponsor.

Sponsor indicates that he will yield. Senator Van Pelt. SENATOR VAN PELT:

Thank you. I'm really -- been working with this Senator for many, many years, even while he was a -- as a Representative, so I'm really happy that he's presenting his first bill here. And I'm standing here to support him. Well, one of the things I'm happy about, as the previous Senator said, is that he removed the vehicle out of the bill, because children shouldn't be driving vehicles. And I'm really happy that you got rid of that, because I'm supportive of all children's rights, but, like you, I agree that children should not be driving vehicles. So you've removed that. So, my question is, just to get the record straight here, are you committed to supporting children's rights all over the world?

PRESIDING OFFICER: (SENATOR HARMON)

Senator Sims.

SENATOR SIMS:

Absolutely.

PRESIDING OFFICER: (SENATOR HARMON)

Senator Van Pelt.

SENATOR VAN PELT:

Let the record reflect that -- that you are committed to supporting children's rights all over the world. And this bill,

even though it eliminates every child's right that exists - because you have eliminated the -- the Bill of Rights for Children - even though it eliminates every bill -- every right for children, you are yet committed to -- to supporting children's rights all over the world?

PRESIDING OFFICER: (SENATOR HARMON)

Senator Sims.

SENATOR SIMS:

Senator, I remain committed to protecting everyone's rights all around the world.

PRESIDING OFFICER: (SENATOR HARMON)

Senator Van Pelt.

SENATOR VAN PELT:

That's why I love you. And I've loved you for a long time for your hard work and commitment. And even though you've just gutted the Children's Bill of Rights, I know that -- even though you -- you removed their right even to have a vehicle - that's good - but I know that over time you will institute every one of those rights back into the law and that our children will be safe. And so with that -- for that reason, I invite everyone to vote Yes, because this is going to turn out good in the end. Thank you.

PRESIDING OFFICER: (SENATOR HARMON)

Thank you, Senator. Is there any further discussion? Oh, Senator Rezin, for what purpose do you rise?

SENATOR REZIN:

Actually, to the bill, Mr. President.

PRESIDING OFFICER: (SENATOR HARMON)

To the bill, Senator.

SENATOR SIMS:

Thank you so much, Mr. President. And for all of my colleagues, when I -- this is -- this is a humbling moment for me also. When I -- when I stood here on this Floor as a staff person years ago, I -- I did not expect to be standing here behind this microphone, so to be able to do that now, at this moment, again, it's a humbling moment for me and I appreciate all of your support on this important piece of legislation. I know we've had some -- some -- some very good ribbing today and there's been some -- some -- some -- and good lighthearted moments, but this is really a serious -- a serious piece of legislation and I appreciate your support.

PRESIDING OFFICER: (SENATOR HARMON)

The question is, shall Senate Bill 5-5-8 pass. All those in favor will vote Aye. Opposed, Nay. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Take the record. On that question, there are 55 voting Aye, none voting No, none voting Present. And Senate Bill 5-5-8, having received the required constitutional majority, is declared passed. Senator Jones, for what purpose do you rise?

SENATOR JONES:

Thank you, Mr. President. I'd like to request a verification of that last roll call.

Thank you, Senator. Senator Raoul moves for the adoption of Floor Amendment No. 1 to Senate Bill 572. All in favor, say Aye. Opposed, Nay. The Ayes have it, and the amendment is adopted. Have there been any further Floor amendments approved for consideration?

SECRETARY ANDERSON:

No further amendments reported.

PRESIDING OFFICER: (SENATOR HARMON)

3rd Reading. With leave of the Body, we're going to move forward to Senate Bill 1008. Senator Althoff. Senator Althoff seeks leave of the Body to return Senate Bill 1008 to the Order of

SENATOR RIGHTER:

Senate Bill 2281 is a simple bill. It expands on a piece of legislation that was sponsored in this Chamber last year by Senator Holmes. It was signed into law by the Governor. Creates the Entrepreneur Learner's Permit program. This bill would simply expand the permit program to all industries. It retains the fiscal cap that was in the original legislation. President Trump, on April 4th of this year, signed a proclamation to decrease illegal immigration and stop border crossings. 1.3 trillion dollars' spending in March that did not include the border wall.
