SENATOR FOWLER:

Thank you, Mr. President. This is a vehicle bill to Senate Bill 3467, which passed out of the Commerce and Economic Development Committee. This bill removes provisions from Senate Bill 3467 that provides a HUBZone small business's price bid for a State contract shall be deemed lower, if the bid is within ten percent of a competitor's bid. Senate Bill 2675 simply codifies federal HUBZone definitions. It allows procurement officers to establish rules relating to HUBZones and to the Illinois Procurement Code. HUBZones are administered by the U.S. Small Business Development Administration. The boundaries for HUBZone areas in the State are set by the SBA. They are set in areas that have a low median household income or historically high unemployment. HUBZone areas are intended to increase employment opportunities and stimulate capital investment. I'm not aware of any opposition and I would request an Aye vote, please.

PRESIDING OFFICER: (SENATOR LINK)

Is there any discussion? Seeing none, the question is, shall Senate Bill 2675 pass. All those in favor, vote Aye. Opposed, Nay. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Take the record. On that question, there are 52 Ayes, no Nays, none voting Present. Senate Bill 2675, having received the required constitutional majority, is declared passed. Senate Bill 2744. Senator Althoff. Senator Althoff seeks leave of the Body to return Senate Bill 2744 to the Order of 2nd Reading. Leave is granted. Now on the Order of 2nd Reading is Senate Bill 2744. Mr. Secretary, are there any Floor amendments approved for consideration?

Senator Althoff, on your amendment.

SENATOR ALTHOFF:

Becomes the bill. I'll explain it on 3rd after its adoption. PRESIDING OFFICER: (SENATOR LINK)

Is there any discussion? Seeing none, all those in favor will say Aye. Opposed, Nay. The Ayes have it. The amendment is adopted. Are there any further Floor amendments approved for consideration?

SECRETARY ANDERSON:

No further amendments reported.

PRESIDING OFFICER: (SENATOR LINK)

3rd Reading. Now on the Order of 3rd Reading is Senate Bill 2744. Mr. Secretary, please read the bill.

SECRETARY ANDERSON:

Senate Bill 2744.

(Secretary reads title of bill)

PRESIDING OFFICER: (SENATOR LINK)

Senator Althoff, on your bill.

SENATOR ALTHOFF:

Thank you, Mr. President. Senate Bill 2744 passed out of committee yesterday unanimously. It amends the Property Tax Code. Makes changes concerning qualifications for township or multitownship assessors and supervisors of assessments. It provides that certain notices shall be posted on the Department of Revenue's official website. It provides that the effective date of a certificate for designation as a pollution control facility shall

be the date of recommendation by the Illinois Environmental Protection Agency to the Illinois Pollution Control Board and it also moves the application process for qualified water treatment facilities from the Department of Natural Resources to the Department of Revenue. I know of no opposition and would ask for an Aye vote.

PRESIDING OFFICER: (SENATOR LINK)

Is there any discussion? Seeing none, the question is, shall Senate Bill 2744 pass. All those in favor will vote Aye. Opposed, Nay. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Take the record. On that question, there are 51 Ayes, no Nays, none voting Present. Senate Bill 2744, having received the required constitutional majority, is declared passed. We will turn to page 16 of the printed Calendar, House Bills 3rd Reading, House Bill 5121. Senator Manar. Mr. Secretary, please read the bill.

SECRETARY ANDERSON:

House Bill 5121.

(Secretary reads title of bill)

PRESIDING OFFICER: (SENATOR LINK)

Senator Manar, on your bill.

SENATOR MANAR:

Thank you, Mr. President. This bill is identical to a bill that was approved by the State Government Committee in the Senate, 3233, and it incorporates language that we refer to as the Truth in Hiring Act. It simply states that the budget of the Governor's Office should be reflective of the personnel that work for the Governor's Office. I don't know of any formal opposition to the

bill. I think there's some expressed opposition, but I'd be happy to take any questions from the Members.

PRESIDING OFFICER: (SENATOR LINK)

Is there any discussion? Senator Righter, for what purpose do you rise?

SENATOR RIGHTER:

Thank you very much, Mr. President. I wonder if the sponsor will yield, please.

PRESIDING OFFICER: (SENATOR LINK)

Indicates he will.

SENATOR RIGHTER:

Senator Manar, just for clarity's sake, your intention is that this would be a -- become effective for what fiscal year?

PRESIDING OFFICER: (SENATOR LINK)

Senator Manar.

SENATOR MANAR:

So it's -- it's a little complicated, but give me a chance to explain it. With -- with the amendment that was added on in the House, the timing of the enactment of this bill related to the timing of the passage of a budget, excuse me, would determine the effective date. So as we know in recent years that the timing of the budget has been suspect to many factors. I'll give you an -- a hypothetical. If a budget is passed and signed into law in May and this bill is signed into law in July after the enactment of the budget, then it would be applicable to fiscal year '20. If it's the other way around, it would be applicable to fiscal year '19, the upcoming fiscal year that starts on July 1st.

PRESIDING OFFICER: (SENATOR LINK)

Senator Righter.

SENATOR RIGHTER:

So the -- the fiscal year to which this would apply depends upon things that have nothing to do with the content of the bill. It has to do with the timing of -- of two separate events, neither of which can be controlled by what you've put on -- what you've put in the bill.

Senator Manar.

SENATOR MANAR:

Yes, that is correct.

PRESIDING OFFICER: (SENATOR LINK)

Senator Righter.

SENATOR RIGHTER:

What's your preference?

PRESIDING OFFICER: (SENATOR LINK)

Senator Manar.

SENATOR MANAR:

So my preference, I -- I would hope would be everybody's preference, which is we get back to some element of norm when it comes to budget making and adoption and, you know, we can get that done in May -- before May 31st. That takes precedent over this bill in my opinion. That's not diminishing the value of the proposal, but if that were the case, Senator Righter, then the provisions in this bill would be applicable to the following fiscal year's budget.

PRESIDING OFFICER: (SENATOR LINK)

Senator Righter.

SENATOR RIGHTER:

Okay, Senator Manar, I'm going to cleverly try to put some

words in your mouth and see if you'll be okay with this. Yes. Is it fair to say that your intent and desire is that for the terms of this bill to be applicable for fiscal year '20?

PRESIDING OFFICER: (SENATOR LINK)

Senator Manar.

SENATOR MANAR:

Not quite, but close. So if -- if a budget is passed, which I hope it is, which we're working toward, before May 31st, I would hope that the Governor also signs this bill, because as part of the discussion, this has been happening going back to administrations on both sides of the aisle and the opposite side of the aisle has always expressed frustration about how Governors of both parties have handled their budgets. So I would hope that we pass a budget before May 31st that gets enacted and the Governor signs this bill. Whether or not he does that before or after is out of my control as well. So, in that scenario, the intent of this bill would be for it, as it's written, to be enacted in fiscal year 2020.

PRESIDING OFFICER: (SENATOR LINK)

Senator Righter.

SENATOR RIGHTER:

Thank you.

PRESIDING OFFICER: (SENATOR LINK)

Senator Tracy, for what purpose do you rise?

SENATOR TRACY:

Thank you -- thank you, Mr. President. To the bill.

To the bill.

When we first heard this bill in State Government Committee and when we consider the -- the terminology of offshoring and transparency and governmental reform, it seems like good practice to go back to a -- a new era where no Governor can do this anymore, and certainly it was started several administrations before, but when you peel back the layers, there are actually some good government reasons for doing this. And entering into intergovernmental cooperation agreement does allow the Governor's Office to access federal funds. For instance, the Early Childhood Development, it operates primarily on federal funds. of Governor runs on General Revenue Funds, so it cannot receive, through the Governor's Office directly, these federal funds. But we need those federal funds to help us implement our Early Childhood Development. So an intergovernmental agency agreement is then used so that another State agency can act as the fiscal agent and receive funds and pay the Governor's Office staff for their services in Early Childhood Development. So that would be one area that the terminology "offshoring" might in fact be a good government reason, because we want to access as much federal funds, especially in the area of education. Likewise, the Dunn Fellowship Program, it was moved to a intergovernmental agency agreement between Department of Central Management Services and the Government's {sic} Office and it allowed the Dunn Fellow Program to make use of the assistance and procedures of the operational -- time sheets and the -- using the same time systems as the rest of the Governor's staff. There's other examples within Health and Human Services, the -- the Innovation Incubator. It is one program that they worked with a intergovernmental agency agreement. I'm just saying, let's not be hasty and act to do away with

something. Maybe we should learn more about it; that there are reasons that it makes good sense and not just good political terminology. So I would ask everybody to reconsider and therefore I will be a No vote, even though I -- you know, at the first part, it sounds like good reform transparency. Perhaps there's another way using these intergovernmental agency agreements we can accommodate both purposes, have the transparency and the ability to access funds or make better efficiency and operational cooperation. I mean, certainly the agencies do operate under the Governor and that, I think, is -- is reason enough to allow this flexibility. So, therefore, I will be a No vote. Thank you.

PRESIDING OFFICER: (SENATOR LINK)

Senator McCarter, for what purpose do you rise?

SENATOR McCARTER:

Questions of the sponsor.

PRESIDING OFFICER: (SENATOR LINK)

Indicates he will yield.

SENATOR McCARTER:

Senator, is -- is this bill similar or identical to your bill SB 3233?

PRESIDING OFFICER: (SENATOR LINK)

Senator Manar.

SENATOR MANAR:

It's identical to the Senate bill, as amended.

PRESIDING OFFICER: (SENATOR LINK)

Senator McCarter.

SENATOR McCARTER:

In the State Government Committee, this passed out unanimously, I might add. Let me ask you a couple of questions,

and these are kind of repeats of what we talked about in that committee. Have both Democrats and Republicans practiced this in the past?

PRESIDING OFFICER: (SENATOR LINK)

Senator Manar.

SENATOR MANAR:

Yes, Governors of both parties have participated in the practice of offshoring salaries of employees that are devoted to that Office specifically, to agency budgets, drawing out of appropriations that were in many cases not intended for people, but for programs - both sides of the aisle.

PRESIDING OFFICER: (SENATOR LINK)

Senator McCarter.

SENATOR McCARTER:

So, this -- this concern -- there's a concern apparently over not -- the Executive Branch, the Governor, not having the influence that he wants within these different departments, having someone there to make sure they're guided according to his wishes, which we understand that. Right? I mean, we understand that he wants to have that guidance of -- of where those departments are going. Is there any reason that, even though these -- say, someone that was Human -- in -- wants to be -- have influence over Human Services could not be in his budget, but be the person responsible for having influence in Human Services? Any reason that couldn't take place?

PRESIDING OFFICER: (SENATOR LINK)

Senator Manar.

SENATOR MANAR:

No, there is no reason and I would -- I would argue to answer

your question, Senator McCarter, that happens today as well. There are employees that are direct employees of the Governor's Office, who are tasked with making sure that the administration's desires, having been elected the Chief Executive, are carried out by agencies. So that happens today. What also happens today is the opposite of that when it comes to accounting for how salaries are paid for in the budget of the Governor's Office. So it happens both ways. We -- we're just saying, let's just make sure it happens this way. And -- and the intent of this bill is not to say that a Governor shouldn't be able to manage agencies and the direction of agencies; the -- the intent is to say, let's have a true accounting of what the cost of an office is.

PRESIDING OFFICER: (SENATOR LINK)

Senator McCarter.

SENATOR McCARTER:

To the bill.

PRESIDING OFFICER: (SENATOR LINK)

To the bill.

SENATOR McCARTER:

Ladies and Gentlemen, I remind you when I was -- I was standing here last week complaining about a bill where the Democrat side wanted to take over the -- and overturn the ruling of our IEPA, I said it was wrong and I said I would -- it was wrong even if the roles were reversed. Well, here's one of those times. This is a bill of -- for transparency, both Democrats and Republicans are practicing this in the past. Now it's time to do it right. With a Republican Governor, with a Democrat Governor, there's no reason not to be transparent in this way. This is a good bill. So, let me just remind you, I think we should do more of this,

maybe less legislation, but more legislation that is good in principle and less in partisanship and probably would produce more for the people of Illinois. I urge an Aye vote.

Senator Rezin, for what purpose do you rise?

SENATOR REZIN:

Question for the sponsor, Mr. President.

PRESIDING OFFICER: (SENATOR LINK)

Indicates he will yield.

SENATOR REZIN:

Thank you. Senator Manar, can you tell me -- so we talk about transparency in this bill, so we agree with that - we think it's a good transparency bill. Do you feel after the election, regardless of who wins in November, that this bill will still stay in effect regardless of the outcome in November?

PRESIDING OFFICER: (SENATOR LINK)

Senator Manar.

SENATOR MANAR:

Yes, I would, and -- and I've -- I said this in committee, said it many times publicly, that I've been an equal opportunity critic about administrations on both sides of the aisle that have utilized this to deflate the appearance of perhaps the size of the budget of the Governor's Office. So, that's not going to change, at least from my own perspective, that's not going to change regardless of the outcome of an election.

Senator Rezin. Senator Manar, to close.

SENATOR MANAR:

Thank you, Mr. President. I appreciate the questions about

I also want to offer my compliments to the Comptroller for putting this bill together and also working with both sides of the aisle to address concerns, many of which we just talked about in debate. I think one of the speakers said it very appropriately. This bill is about transparency for State government, raising the level of transparency about how money is spent in the Governor's Office, and as I stated a few moments ago, that should be applicable to -- regardless of the individual or the political party that runs that particular office. I ask for an Aye vote. PRESIDING OFFICER: (SENATOR LINK)
