We are looking at this bill from a perspective of something that was negotiated very aggressively last year in our -- where we went to the evidence-based model in our school education. Two things that we felt were very important: One was, of course, with regard to our funding that we could do outside of the education process; the other one was with regard to this mandate waiver. I know, when I was out talking to people in the district, I was very proud to say that we had made this process much easier, where local districts would have the ability to come back with a requested waiver and only have that waiver addressed by four Leaders or four people who were representing the Leaders of the four caucuses. It would take three of those people to vote No. I thought it was a very good process. I think it was a fair process. It was an aggressively negotiated process. And to have that pulled back after we had done good faith dealings, I think is inappropriate, and I would aggressively request a No vote on this matter. Thank you.
