Thank you very much. This is the House Transportation Committee bill. It does five things. It says that pickup trucks do not have to have a -- flares and other warning devices unless

they are towing cars. It allows the counties or the townships to post weight restrictions. There is a change in the Motor Vehicle Franchise Act. It allows the antique trolley in Galena to use bells instead of horns. And it allows car dealerships to only display one license plate. Passed out of the House 108 to nothing. I'll be glad to answer any questions.

PRESIDING OFFICER: (SENATOR DONAHUE)

Discussion? Discussion? Senator Raica.

SENATOR RAICA:

Question to the sponsor, Madam President.

PRESIDING OFFICER: (SENATOR DONAHUE)

Indicates she'll yield, Senator Raica.

SENATOR RAICA:

Senator Fawell, you mentioned that it allows car dealerships to display one plate. Is that one plate to customers that test-drive their vehicle, or one plate to people who -- employees who use the dealers' vehicles traveling throughout the State of Illinois?

PRESIDING OFFICER: (SENATOR DONAHUE)

Senator Fawell.

SENATOR FAWELL:

Under this provision -- when a dealer buys plates, he buys a number and he buys a number of plates. Under this provision, instead of the Secretary of State, who is, by the way, on board with this, to give them a hundred plates, he would give them fifty plates, if -- if that's what they bought. So it would allow them to use one plate. It's really for when they test-drive and that type of thing.

PRESIDING OFFICER: (SENATOR DONAHUE)

Further discussion? Senator Raica.

SENATOR RAICA:

Just a clarification, Madam President, if I might. Senator

Fawell, you mentioned this is just for test-driving. So it's not for the employees who use the dealership vehicles? You know, like a dealer -- one of the salesmen takes a car home with him and he currently displays two plates. This -- what you're saying is just for the vehicles that leave the lot that are test-driven within a short distance and not for the employees that -- or, for the salespersons that take vehicles home with them. Right? PRESIDING OFFICER: (SENATOR DONAHUE)

Senator Fawell.

SENATOR FAWELL:

What I have been told is that the -- those dealers that are driving those cars -- they are -- they are for sale, so it would be the same thing.

PRESIDING OFFICER: (SENATOR DONAHUE)

Senator Raica.

SENATOR RAICA:

Senator, my understanding, originally, is that the State police were against this provision, that they wanted -- they did not mind a vehicle that left the lot that was driven a short distance to be test-driven, but they were opposed, originally, to one of the salespeople taking a car home with -- just -- just displaying one plate. Can you tell me, has their opposition been removed from the bill?

PRESIDING OFFICER: (SENATOR DONAHUE)

Senator Fawell.

SENATOR FAWELL:

State police are neutral on this bill, now.

PRESIDING OFFICER: (SENATOR DONAHUE)

Is there further discussion? Further discussion? Seeing none, the question is, shall House Bill 378 pass. Those in favor will vote Aye. Opposed, Nay. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish?
