We finally got up the courage a few -- several years ago, in fact, to put a tax on gasoline to pay for the cleanup. It's obvious this is going to continue for another forty years in the future. I don't see any -- any benefit to putting a sunset on that seven years from now. What that's going to do is force another Legislature to meet to -- to pass an inevitable fuel tax at that time. It seems to me that in order to avoid that, we should just pass this bill without any -- any sunset on it.

PRESIDING OFFICER: (SENATOR DONAHUE)

Senator Maitland.

SENATOR MAITLAND:

Thank you very much, Madam President. Senator Welch, I -- I understand your concern and that -- that concern has been voiced to me by a number of people. Our concern is this is eight-tenths of a cent per gallon. We support very much the legislation and think it needs to happen. As you know, the rules and regulations that we -- that we will use for the whole program have been

altered greatly as a result of -- of Senate Bill 300. We don't know really the amount that's going to be needed. Could be more at some point; could be less. But this is a seven-year program now, eight-tenths of a cent per gallon, which costs a lot of people a lot of money for a long period of time. I'm prepared - and I won't be here - but others should be prepared to revisit this in seven years to see if it's needed or possibly more is needed, perhaps less is needed.

#### SENATOR WELCH:

Well, my understanding, this amendment comes through the -through the drawing of the Farm Bureau. A few years ago when we passed this, we exempted all tanks under eleven hundred gallons, which was designed to take care of the Farm Bureau at that time, and they were happy at that time. To me, this doesn't make sense them to jump back in this when they have already been taken This is an eight-tenth of a cent per gallon tax; care of. however, earlier in this year, we also eliminated the joint and several liability provision that allowed cleanups of many of these gas stations. Now what you're going to have is this: If got a gas station - and let's say it's Phillip's 66 leaks, you've got joint and severable liability. The Joe -- "Joe Six-pack" or whoever, who owns the gas station, is going to be ninety-five percent responsible. Phillip's 66 may be five percent responsible because of the tort reform that we passed earlier. It seems to me that -- that it's inevitable that we're going to need a lot of money to clean these up, and there are so many underground tanks that are still being found, it doesn't, to me, make sense to put this amendment on at the behest of the Farm Bureau, which has almost no -- no coverage under the bill in the first place.

Thank you, Madam President. Senator Welch, with all due respect, sir, you're partially correct and partially incorrect, I believe. Number one, a farmer's tanks are exempt from the -- from the clean-up issue if they're over a thousand gallons. If we have a two-thousand-gallon tank, we are -- we are included. But vou're eleven hundred gallons. But we pay the tax. We pay the tax anyway. That eight-tenths of a cent is paid by farmers and truckers and everybody across this State. And we are simply saying that -- and we support the notion. There's no question about that at all. We believe it ought to be done. If I have a leaking underground tank, I have to pay to have it cleaned up. I don't get the benefit of the -- of the -- of the tax at all, and that's fine; I'm willing to pay that. But the point is, why just put a tax on forever - forever - and -- and, you know, not even have any clear-cut knowledge of how long it's going to take to clean up these -- this underground storage problem? I think it's the proper way to go. Yes, Farm Bureau is supportive of this, but there are many other groups that are supportive of it as well.

#### PRESIDING OFFICER: (SENATOR DONAHUE)

I'm going to ask you, please, one more time, to keep your conferences down so we can hear the discussion on the bills before us. Senator Mahar. Excuse me, Senator Welch. Senator Welch:

Well, it just seems to me to be unfair that when the Farm Bureau got the exemption from this -- and that was a contested bill, as I recall. It was at one point five hundred gallons, not eleven hundred. It also exempted all above ground storage tanks as well, at their request. And now, after they've gotten these two exemptions, to come back and say, "Well, on top of getting the exemptions and not be included in the Act, we don't want to pay

the tax either," it -- it just seems to me to -- to strike me the wrong way that they -- they were able to not be included in being required to clean up where they have spills and now they don't want to contribute to spills where -- where there are gasoline stations, usually in municipalities. It just -- it just -- well, that's exactly where most of the gas station spills are, are in cities, in inner cities. We've got situations in my area where ice cream stands that we didn't even know were gas stations, when they go to sell them they do the environmental impact study. They found out this used to be a gas station with a leaking underground tank. Now, that's going to happen throughout Illinois.

Senator Maitland.

#### SENATOR MAITLAND:

Well, Senator Welch, I don't know whether you're confusing everybody else as much as you are confusing me. The farmers are paying the tax. The farmers are paying the tax. If I have a leaking underground tank on my farm - and I have - I don't get the benefit of the cleanup. I have to clean up that leaking underground tank myself. So I'm -- I'm paying the tax and not getting any benefits. That's okay. I'm prepared to do that. But -- but you tell the farmers in your -- in your -- in your district that you're going to put this tax on forever, as this bill does -and keep in mind, Ladies and Gentlemen, the -- the existing three-tenths of a cent is still on. Why just add a tax with no -with no future at all? Just -- just -- let's give it seven years. Maybe we'll need more; maybe we'll need less. That's what I'm prepared to tell the people who I represent.

Senator, this resolution, the text of the resolution makes reference, if I understand it, to the Roe v. Wade decision. Is that correct?

#### SENATOR LAUZEN:

The actual language in the resolution is, on page 1: Whereas, it has been a long-standing policy of the State of Illinois, before the United States Supreme Court decision of January 22nd, 1973, to protect the life of the unborn. And then it goes on. So it does not reference what you're -- what you just referred to, directly, but I -- I would say that that's an indirect reference.

PRESIDING OFFICER: (SENATOR DONAHUE)

Senator Cullerton.

Okay.

PRESIDING OFFICER: (SENATOR DONAHUE)

Is there any further discussion? Senator Watson, to close.

This is brought to us by the Illinois Coal Association and by the United Mine Workers, who suggested it would be a -- a good idea to do that, and it would be effective immediately. Thank you very much, Madam President and Members of the Senate. Senate Joint Resolution 10 creates a six-Member joint committee on Medicaid to review and monitor the Illinois Medicaid Program. The primary focus of the committee will be to monitor the financial condition of the Medicaid Program through possibly public hearings and to monitor the implementation of Medicaid reform enacted by the General Assembly. I know of no opposition, and I would seek support of the Body.

## SENATOR DEMUZIO:

Senator Maitland, I certainly don't disagree nor quarrel with the objective that you are attempting to achieve here; however, I might ask this question of you: This is to be a review and oversight committee, is that correct?

Senator Maitland.

## SENATOR MAITLAND:

That is correct.

PRESIDING OFFICER: (SENATOR DONAHUE)

Senator Demuzio.

seems to me that if it is truly to be a committee that is going to review, and particularly if it is an oversight committee, it would seem to me that there would be bipartisan support in the appointments. If you want true oversight of this significant problem, it seems to me that there ought to be the equal number of -- of Senators and House Members from each political party represented on this committee, if it to have the credibility that I think that you wish it to have. And I would suggest that if it is of the nature that I have mentioned in terms of your objective, to -- to truly oversight and to truly review, I would suggest that it ought to have equal representation from both the -- both Chambers and both parties and would ask that if that is your notion, perhaps we could amend this and make sure that we do have the equal number of Members would give you the credibility that I think you're seeking on this committee.

## PRESIDING OFFICER: (SENATOR DONAHUE)

Further discussion? Senator Welch.

#### SENATOR WELCH:

Yes. Well I'd just like to point out for the Body what's -- what's happening here. The two major issues that we've been facing this year have been the Medicaid issue and funding education. Senator Maitland, as you know, two bills at least, and I expect there have been more - one was closing the loophole in Section 25 that I sponsored; another one was one that Senator Dunn sponsored on making certain that the new revenue goes toward paying off old Medicaid bills - both have been defeated. In fact, you actually opposed both of those bills. Do you expect this committee is going to, in any serious way, consider how this State, finally, is going to catch up on its old Medicaid debt and to bring it down to a screeching halt, rather than the approach that we've been taking?

I rise to express my concerns about this resolution, because as a co-chair of the Democratic Leaders' Task Force on Medicaid and Welfare Reform, we would like to have equal input as the sponsor of this piece of -- of this resolution should be able to provide in this legislation. I'd also like to point out that earlier during the Session, Senate Bill 1170, which was sponsored by Senator Jones, which was defeated in committee, would have provided for equal representation on such a task force, and that's why I would urge the Members on this side of the aisle to vote Present on this matter.

We have visited the issue that is contained in Senate Joint Resolution No. This is the so-called State Sovereignty amendment. basically states and restates for the Members of Congress is the Tenth Amendment. It reminds Congress that they should not be sending mandates back to the State, such -- such as rules that we're going to deal with, for example, in -- in a resolution sponsored by Senator Mahar - I believe it's the succeeding resolution - but basically is a restatement of relationship between states and the federal government. The resolution has its impetus from a Supreme Court case in which the United States Supreme Court held that Congress does not have -- should not commandeer the regulatory processes of state and substitute its own judgment. And, Madam President and Members of the Senate, I would move for the adoption of Senate

#### SENATOR PETKA:

Senator, this resolution does not advance the theory of the John C. Calhoun in nullification. Does not.

Well, it does claim that -- it reiterates the Tenth Amendment. By doing so, it infers only, but not allows, for a state to refuse to follow a federal statute? I'm not sure what the point is. If you're just restating the Tenth Amendment, we did that pretty well about three weeks ago, requiring all schools to post that, if somebody requests it. But in this one, what -- what is the point, if you're not doing more than restating the Tenth Amendment to the U.S. Constitution?

PRESIDING OFFICER: (SENATOR DONAHUE)

Senator Petka.

# SENATOR PETKA:

You're certainly correct, Senator. It is more than that. -- the Congress, over the last forty or fifty years, has gotten into a very bad habit, and that habit is to begin -- or to -- to programs which are, in some instances, not: unconstitutional, but also without any money to implement the -those programs. What we are saying here in -- in the State of Illinois, hopefully, with this resolution is: Look, for forty or fifty years, you've sent -- sent us mandates that are unfunded, you have passed legislation which has required us to challenge you in a court of law. Let's just stop the -- the nonsense. Let's get back to, really, the relationship of the states. You are, in essence, not our master but our agent.

So by voting for this, basically we're saying that Illinois doesn't have to pass the motor-voter bill is -- is what you're saying; that that is a federal -- unfunded federal mandate that goes beyond the Tenth Amendment to the Constitution and basically gives a legal basis, should Illinois go to court -- to a federal court, to say we're not going to -- to follow and enact the motor-voter law, because, look, we've got this resolution of the State Legislatures saying that we don't have to do it. This resolution urges the United States Congress to -- to improve the administration of the Food Stamp Program, primarily in the area of making it more stricter as to what type of goods could be purchased with food stamps. We feel that more nutritious, healthy, even more economical foods should be encouraged, and we are asking Congress to adopt these tighter controls.
