May I have your attention, Ladies and Gentlemen? May I have your attention? Senator Shadid has some distinguished guests from Russia that he would like to introduce. Senator Shadid.

## SENATOR SHADID:

Thank you, Mr. President. If I could just -- you'll bear with me, I'd like to introduce you to a delegation from Russia who are in our great State of Illinois and they're touring our prison system, and they are quests of the FHL, which is the Faith, and Love prison ministry that originated in 1978. So if you'll bear with me. And when I get to reading their names, if I need any help, I'll ask for Senator Dudycz to read the Russian names for me. And I'm kidding you, Senator. Okay. I'm very pleased to welcome to Springfield today four Russian delegates and their interpreter who are visiting Illinois at the invitation of Ed Meister, Chairman of Faith, Hope and Love, and Senior Chaplain Paul Meister, to inspect and tour the prison systems in Illinois. Faith, Hope and Love is а nondenominational, volunteer organization chartered in 1978 to minister to spiritual and other

needs of men and women in Illinois' prisons, jails and work release camps. During the past year, Faith, Hope and Love's over four hundred volunteer chaplains logged over fifty thousand volunteer hours at Illinois correctional centers and over ten thousand volunteer hours at county jails, as well as operating a program for troubled youth and a halfway house in Peoria for recently released prisoners. When Faith, Hope and Love volunteer Howard Getz served as a missionary in Russia, he took time continue his prison ministry by visiting with prisoners in the corrections system in the Republic of Karelia in northwestern Russia. Karelian officials were so impressed with Faith, Hope and Love's work they expressed great interest in visiting the United States to observe the operation of the corrections system in this And if you'll bear with me, I will introduce these folks, and if I have a little problem with some of the names, just overlook that, please. The names of the delegates, as follows: Colonel Aleksandr Safronov, who is the Vice Minister of the Ministry of Internal Affairs of the Republic of Karelia. you'll -- if you'll hold your applause until I introduce them all, I'd appreciate it. Colonel Aleksandr Safonov. He's the Director of Karelian Penalty Execution Service - which doesn't mean what you think. What he does is execute the system and the paperwork; he doesn't execute all the people. Lieutenant Colonel Vladimir Shabalov. He's the Head of the Organization -- Organizing and Inspecting Department of the Karelian Penalty Execution Service. Lieutenant Colonel Anatoliy Skonknin, Chief of the Prison of the Karelian Penalty Execution Service. And our Interpreter, who will introduce Colonel Safronov to make a brief statement, Larissa Mikhailova.
