Senator Palmer, for what purpose do you rise?

SENATOR PALMER:

Thank you, Mr. President. A point of personal privilege.

PRESIDENT PHILIP:

State your point.

SENATOR PALMER:

I'd like to introduce the members from the Randolph Magnet Elementary School, who are on this side of the aisle in the balcony. And especially today, there is a young woman here who is an honorary Page, Cyndi McLendon. Her mother is in the balcony, as well as her teacher. And I ask that we recognize and acknowledge them.

PRESIDENT PHILIP:

If they'll please rise and be recognized by the Senate.

PRESIDING OFFICER: (SENATOR DeANGELIS)

On page 3 of today's Calendar is the Order of Motions in Writing to Accept Specific Recommendations for Change. Senator Klemm. Senate Bill 1122. Mr. Secretary, do you have a motion on your desk regarding Senate Bill 1122?

Yes, Mr. President. I move to accept the specific recommendations of the Governor as to Senate Bill 1122, in manner and form as follows:

Senator Klemm.

SENATOR KLEMM:

Thank you, Mr. President. Senate Bill 1122, I move the -- the acceptance of the Governor's recommendation, and let me explain to the Body what those changes were. This was particularly about our State scholarships that the General Assembly Members award as a legislative scholarship. And what -- if you recall last year, we were trying to get some definitions and also trying to define some identity of who those individuals would be who receive the recommendations of scholarship awards. The Governor had -- staff had talked to me about trying to expand the definitions and requirements, and I certainly agree, and most of us certainly felt that last year. So the Governor, I think wisely, and I support his efforts in trying to change it. And basically what we're doing is having not only the nominee's name, but we're also asking for their address, the university they attend, the program in which they're enrolled in, the amount of tuition waived by the legislator's scholarship, and also we ask that the statement by the nominee -- has a waiver document that also would contain this statement: that if, in fact, the nominee does not live in the area that they say they are, that the nominee would have to that scholarship would be revoked by the State Board of Education after a hearing, and if they found that the person did, in fact, mislead the legislator, that that nominee would reimburse the university for the full amount of the waiver that they were granted. Those changes, I think, are essential to restore some of the integrity that we all follow and have followed. Through the years, there's been some problems, perhaps. We think this change will certainly rectify that and bring, again, the measure of integrity that we want on these scholarships. So I do ask for your approval and support.

Senator Geo-Karis.

Mr. President, will the -- with the noise in here, I could hardly hear the explanation, but may I refer my question to the sponsor? Will he...

Senator, this is the -- would you just give me, in one sentence, what's the major change of this bill?

Well, the major change is as I explained. It was the expansion of just providing the name of the individual being awarded the scholarship, but also where they live, what school they attend, as I mentioned. That would be the expansion of it. PRESIDING OFFICER: (SENATOR DEANGELIS)

Senator Cullerton.

SENATOR CULLERTON:

Yes. Would the sponsor yield?

PRESIDING OFFICER: (SENATOR DEANGELIS)

Sponsor says he will yield.

SENATOR CULLERTON:

Senator, what is the effective date of this bill, and what's the impact of the legislation on current scholarship recipients?

PRESIDING OFFICER: (SENATOR DEANGELIS)

Senator Klemm.

SENATOR KLEMM:

I did hear the first part of your question. The effective... PRESIDING OFFICER: (SENATOR DEANGELIS)

What is the effective date of this bill and what is the effect of this legislation, if passed, on current scholarships?

Well, I understand the effective date would be upon acceptance of the -- immediate - I guess I would have to say that - on acceptance of the Governor's recommendation. It does not have any effect, as yet, on those that are receiving scholarships in the term of the scholarship they've already received. On a new designation, or a new scholarship award, then it would apply.

PRESIDING OFFICER: (SENATOR DEANGELIS)

Senator Fawell.

SENATOR FAWELL:

Senator, will you yield for a question?

PRESIDING OFFICER: (SENATOR DEANGELIS)

Sponsor says he will yield.

SENATOR FAWELL:

I notice that we also are supposed to tell how much money this will involve, as far as tuition. Is -- are the schools going to give us that -- that number, because I certainly don't have any idea?

PRESIDING OFFICER: (SENATOR DEANGELIS)

Senator Klemm.

SENATOR KLEMM:

Yes. The schools would provide that for us.

PRESIDING OFFICER: (SENATOR DEANGELIS)

Any further discussion? If not, the question is, shall the Senate accept the specific recommendations of the Governor as to Senate Bill 1122, in the manner and form just stated by Senator Klemm. Those in favor will vote Aye. The opposed will vote Nay. The voting is now open. Have all voted who wish? Have all voted

who wish? Have all voted who wish? Take the record. On that question, there are 56 Ayes, none voting Nay, none voting Present. The specific recommendations of the Governor as to Senate Bill 1122, having received the required constitutional majority of Senators elected, is declared accepted. SENATOR SHADID:

Point of personal privilege.

PRESIDING OFFICER: (SENATOR DEANGELIS)

State your point.

SENATOR SHADID:

I would like to introduce in the gallery the County Recorder from Peoria County, Dirk McGinnis, who is present.

PRESIDING OFFICER: (SENATOR DEANGELIS)

Senate Bill 1425. Senator Madigan. Mr. Secretary, is there on the Calendar on the Order of Motions -- is there a -- read the motion, please.

ACTING SECRETARY HAWKER:

I move to accept the specific recommendations of the Governor as to Senate Bill 1425, in manner and form as follows:

PRESIDING OFFICER: (SENATOR DEANGELIS)

Senator Madigan.

SENATOR MADIGAN:

Thank you, Mr. President. Senate Bill 1425 dealt with the issuance of insurance policies to people that may be subject to domestic abuse. When the bill was passed and sent to the Governor, it included accident and health insurance policies, which was inadvertent. The Governor, in his wisdom, has deleted accident and health insurance from the language of Senate Bill

1425, and I would ask the Senate to accept this change by Governor Edgar.

PRESIDING OFFICER: (SENATOR DEANGELIS)

Senator Welch.

SENATOR WELCH:

I have a question of the sponsor.

PRESIDING OFFICER: (SENATOR DeANGELIS)

Sponsor says he will yield.

SENATOR WELCH:

Senator Madigan, prior to the Governor's veto, did the bill say that if a person is subject to domestic abuse, an insurance company cannot discriminate them on life insurance or health insurance or other types of insurance? Is that what the bill said before the veto?

PRESIDING OFFICER: (SENATOR DEANGELIS)

Senator Madigan.

SENATOR MADIGAN:

That is correct, Senator Welch.

PRESIDING OFFICER: (SENATOR DEANGELIS)

Senator Welch.

SENATOR WELCH:

Well, then, what is the rationale of eliminating the requirement that an insurance company insure an individual for health insurance who's the subject of domestic abuse? I'm not sure I understand why we don't want to make sure that those individuals have insurance.

PRESIDING OFFICER: (SENATOR DEANGELIS)

Is that a question? Senator Madigan.

SENATOR MADIGAN:

Thank you, Mr. President. Senator Welch, the purpose of the bill was to avoid a problem where a person who may be the abuser would benefit by -- from the insurance contract by abusing the --

by abusing someone in the family. That is -- we intended to do this for the purpose of life insurance policies. Obviously, accident and health policies should not have been included, which the bill did. We're taking accident and health policies out of that, but leaving the life insurance policy language in.

PRESIDING OFFICER: (SENATOR DEANGELIS)

Senator Welch.

SENATOR WELCH:

Well, I understand the theory behind the -- the life insurance, but it doesn't make sense to me to eliminate the other types of insurance. Why not eliminate discrimination on those too? It seems to me a -- a one-in-a-million chance here that an individual spouse will abuse the other one because they think they're going to collect the benefits. You know, that rationale could be used by an insurance company for any kind of policy and to negate any coverage for anybody.

PRESIDING OFFICER: (SENATOR DEANGELIS)

Are you done, Senator Welch? Senator Welch.

SENATOR WELCH:

There is a question mark at the end of that statement.

PRESIDING OFFICER: (SENATOR DEANGELIS)

That's two times. Senator Madigan.

SENATOR MADIGAN:

Thank you, Mr. President. Senator Welch, we're eliminating the discrimination as far as accident and health. In other words, this is not to the benefit of the insurance companies. This is of benefit to the -- by this amendatory veto, we're eliminating the discrimination for someone who may be abused and not being able to access an accident and health policy.

PRESIDING OFFICER: (SENATOR DEANGELIS)

Senator Berman.

SENATOR BERMAN:

Thank you, Mr. President. Senator Madigan, on the same subject - and I'm -- I'm a little confused by the language of this - could you indicate -- as I understand your response to Senator Welch, it is not the intent of this bill to deny coverage to a person who has been the victim of abuse. Is that correct?

PRESIDING OFFICER: (SENATOR DEANGELIS)

Senator Madigan.

SENATOR MADIGAN:

That is correct, Senator Berman.

PRESIDING OFFICER: (SENATOR DEANGELIS)

Senator Berman.

SENATOR BERMAN:

Then let me ask you, under section (b), why would we have the following language? Quote: Nothing in this Section shall be construed to prohibit a company from refusing to insure on the basis of that individual's physical or mental condition regardless of the underlying clause {sic} (cause) of such condition. That seems to be -- an -- a -- a doorway that any insurance company could walk through to say, "Mrs. Smith, because you were the victim of abuse, we don't want to write you." Could you explain that language in relation to your previous answer?

PRESIDING OFFICER: (SENATOR DEANGELIS)

Senator Madigan.

SENATOR MADIGAN:

Well, the intent of the bill, Senator Berman, is to prevent insurance companies with this language, or this bill -- the intent of this bill is to prohibit the insurance companies from asserting that provision on people that may be subject or -- to domestic abuse. They still reserve the right to -- for other physical or mental conditions, they still would reserve their right - the insurance company reserves their right - to refuse coverage for some other -- for some other reason, under a physical or a mental

condition.

PRESIDING OFFICER: (SENATOR DeANGELIS)

Senator Berman.

SENATOR BERMAN:

Well, I -- I hear your answer, but the language doesn't seem to say that. As I read this, if -- if a woman is the -- is the victim of abuse, this language allows a insurance company to refuse to cover her. Now, I'm -- I -- I voted for this bill. The language was in it. But in the several months that we have been gone, this has come to my attention, and I've read it over and over. Let me -- let me just request, and I'm being very sincere: Could we take it out, look at the language and better understand it; maybe call it tomorrow? I -- I understand your sincerity, and I -- I just don't read it that way.

PRESIDING OFFICER: (SENATOR DEANGELIS)

Take it out of the record, Madam Secretary. On page 3 of the Calendar in the Order of Motions in Writing to Accept Special Recommendations for Change -- Specific Recommendations for Change is Senate Bill 1467. Read the bill, Madam Secretary.

ACTING SECRETARY HAWKER:

I move to accept the specific recommendations of the Governor as to Senate Bill 1467, in manner and form as follows:
